LIAISONS REPORT

<u>Planning Commission-</u> Supervisor Absher had nothing to report as a result of the March 8, 2012 Planning Commission meeting.

<u>IDA</u> – Supervisor White had no report as a result of the March 28, 2012 IDA meeting. He could not attend. However, Supervisor Stacy attended the meeting as an observer.

<u>Cumberland Plateau Planning District (CPPD</u>) – Supervisor White stated the CPPD held their annual meeting and he was appointed Vice Chair of the Planning District Board. He also reported the CPPD -Amonate Housing Rehabilitation grant had been approved through DHCD.

Emergency Services Report - Supervisor Stacy reported the Emergency Services Committee, at their last meeting, requested funding from the Board of Supervisors to purchase a fire/rescue skid unit to be used with the Kubota recently purchased by Thompson Valley Fire & Rescue.

FIRE/RESCUE SKID UNIT \$7,710.00 APPROVED FOR THOMPSON VALLEY FIRE & RESCUE

And now, following a recommendation from the Tazewell County Emergency Services Committee, and upon motion of Supervisor Stacy, seconded by Supervisor Absher and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves the amount of \$7,710.00 from Account No. 3202-8109 Rescue Squad Capital Outlay, for the purchase of fire/rescue skid unit to be used with a Kubota purchased by Thompson Valley Fire & Rescue. The skid unit will be used to enhance emergency response and safety while supporting other county agencies to efficiently transport injured persons from areas where normal emergency response vehicles cannot respond as well as assisting in brush fire incidences. EMERGENCY EQUIPMENT LIST

Upon motion of Supervisor Hymes, seconded by Supervisor Absher and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby awards a bid in the amount of \$168,500.00 from Account No. 32010-8109, Fire Department Capital Outlay, to Goodman Specialized Vehicles, 9110 Pridesville Road, PO Box 840, Amelia, VA 23002 lowest, responsive bidder, for the purchase of one (1) Deep South Fire Classic Series Tanker fire truck for the Clearfork Fire Department, Tazewell, Virginia. The price includes delivery to the fire department site with warranty and training. The County Administrator is further directed to execute any and all documents in accordance with this action and the County Administrator is hereby authorized and directed to issue said warrant for the purchase of same, and which said warrant will be converted to negotiable check by the Treasurer of Tazewell County, Virginia.

The County Administrator was further directed to write a letter to Jay Shott/Shott Foundation requesting funding assistance with Clearfork Fire Department needs as a result of the development of the Cove Creek Estates subdivision.

<u>Budget Committee</u> – Supervisor Brewster said the County Budget committee met April 2 and addressed various upcoming budget topics including changes to VRS Retirementcontributions by employees. Employees may be required to pay a 5% VRS contribution which may result in a possible 5% + offset by the Board of Supervisors for employees.

CAVITTS CREEK/LAKE JACK WITTEN

The County Administrator, Jim Spencer announced a grand opening ceremony for the new office building at Cavitts Creek/Lake Jack Witten on May 7, 2012 at 4:30 p.m. Supervisor

Brewster further suggested that the County Administrator or designated staff seek grant funding or other funding assistance from the Tobacco Commission or other funding sources to enhance the park/lake amenities for camping, cabins, as well as the possible development of an amphitheater, etc. at the park. Supervisor Brewster further suggested that the County Engineer develop a Master Plan with regard to this endeavor.

VDOT REPORTS

MATT COX - CONRAD HILL

Matt Cox, Virginia Department of Transportation Programming & Investment Mgmt. Director Bristol District Office, presented a draft 2013-2104 through 2017-18- Secondary Six Year Road Plan that detailed each project and likely costs. Conrad Hill, Resident Engineer, Lebanon Residency, accompanied Mr. Cox. Mr. Hill is currently the VDOT representative for road concerns and highway projects in Tazewell County. They highlighted the priority proposed road projects with the Board. The Board of Supervisors will hold a PUBLIC HEARING on the SSYP Projects & Budget at the May 1, 2012 regular meeting. A copy of the proposed draft list as presented this date is on file in the office of the County Administrator, 108 East Main Street, Tazewell, Virginia 24651.

Supervisor White requested the County Engineer's Department send him quotes for repairs to Young's Road in the Raven area.

UNSCHEDULED CITIZEN COMMENTS

Chris Plaster, Attorney representing parents of the Little League Raven football team, reported the Richlands Midget League Football, Inc. voted March 11 to disband the Raven team and move the players to Richlands. Mr. Plaster said he felt if the team was disband many of the Raven children would not play and said Raven has more than enough players to fill teams in the smurf and pee-wee league, but not in the midget group. Supervisor White and Supervisor Absher has given money to the league over the past few years and said they would attend to have a meeting with the Richlands Little League in hopes to obtain information regarding the disbandment. Supervisor White requested that the Assistant County Administrator write a letter to the Richlands Little League on behalf of the Board of Supervisors giving an explanation of previous funding from the County and possibly the withdrawal of funds from the County if the issues are not resolved.

BACK OF THE DRAGON LARRY DAVIDSON

Larry Davidson, Thompson Valley, and Coordinator of the Route 16 to Marion stated the General Assembly on March 16, 2012 designated Route 16 as "Back of the Dragon". Mr. Davidson said he anticipates the designation to become a tourism attraction from Marion to Tazewell and the revenues for Tazewell County are expected to be great. He further requested that the Virginia Department of Transportation repair the road on Route 16 to the Smyth Mountain Line. He said the Brushy Mountain side was in deplorable condition and if people riding their motorcycles would wreck the road it would be labeled a dangerous road and would kill the tourism approach. Conrad Hill, VDOT representative said the department would work on ways to smooth out the road. The 2012 Back of the Dragon event will take place June 2 and begin on Main Street in Tazewell – vendors will be set up in both Tazewell and Marion.

BOY SCOUT TROOP 93

Chris Calo – Leader for Tazewell area Boy Scout Troop 93, introduced Senior Scout members who are working on the citizenship and community merit badge. Board members welcomed Mr. Calo and his group and wished them well in their upcoming merit accomplishments.

VDOT REPORTS

The Chairman then went back to the VDOT update portion of the agenda. Mr. Conrad Hill highlighted various transportation issues and said he would be the contact person for the Tazewell area. Supervisor White requested VDOT's assistance by studying the Raven 460 bridge project for safety concerns as well as making repairs to road shoulders in the Doran area. Supervisor Absher requested VDOT's assistance by studying ways to identify the turn lanes more safely at the Claypool Hill Wal-mart. Mr. Hill said he would study the requests and make a written report to the Board of Supervisors. A Coal Severance Tax Workshop will be held April 9, 2012 to review the Revenue Sharing Budget & projects as well as Rural Addition Road monies.

SIX YEAR SECONDARY ROAD PLAN – PUBLIC HEARING AUTHORIZED

REDISTRICTING ORDINANCE – REPEAL DECEMBER 6, 2011 ORDINANCE

Upon motion of Supervisor Brewster, seconded by Supervisor Absher and adopted by a vote of 4 to 1, with Supervisor White voting nay, the Tazewell County Board of Supervisors hereby adopts a proposed Redistricting Ordinance repealing the December 6, 2011 consolidation of Gap Store and Adria Precincts and restore those precincts and their respective polling places to those established in the April 26, 2011 Ordinance, to strike paragraph 1 that would have relocated the Gap Store polling place to Dailey's Chapel, to add to the last sentence of paragraph

3 the following language: "including the polling places thereby established, namely the Baptist Valley Fire Department and L & G Auction House", and to strike reference to relocating the Gap Store polling place from the third "Whereas" paragraph – as set forth below:

AN ORDINANCE TO AMEND AN ORDINANCE TO PROVIDE FOR THE REDISTRICTING OF THE BOUNDARY LINES OF THE BOARD OF SUPERVISORS ELECTION DISTRICTS, AND PRECINCTS WITHIN TAZEWELL COUNTY, VIRGINIA; ENACTED APRIL 26, 2011, PURSUANT TO VIRGINIA CODE, SECTIONS, 15.2-1211, 15.2-1425 & 24.2-304.1 et seq. (1950), AS AMENDED

WHEREAS, the Board desires to make the County's polling places accessible to residents with disabilities for voting, serving as election officials, serving as election observers, and otherwise participating in the election process;

WHEREAS, the Board also desires to make voting more convenient for all voters;

WHEREAS, the Board approved an Ordinance to Establish Electoral Districts, Precinct Boundaries, and Polling Places, on April 26, 2011;

WHEREAS, on December 6, 2011 the Board enacted an Ordinance amending the boundaries of four precincts set forth in the April 26th Ordinance; thereby consolidating Gap Store and Adria precincts into a new Baptist Valley East Precinct and adjusting the boundary between the Graham and Springville Precincts so as to reduce the number of voters in the Graham Precinct.

WHEREAS, the Board now desires to repeal the consolidation of the Gap Store and Adria Precincts;

NOW THEREFORE, the Board hereby does ORDAIN as follows:

1. That Section 4 of the April 26, 2011 Ordinance Establishing Electoral District Boundaries, Precinct Boundaries, and Polling Places hereby is amended to establish the boundaries of Graham Precinct and Springville Precinct as therein set forth to conform to the Boundaries set forth in "Exhibit A" hereto and as described on the Map attached hereto as a part of "Exhibit A."

2. That the provisions of the December 6, 2011 Ordinance consolidating the Gap Store Precinct and the Adria Precinct hereby are repealed and said precincts hereby are reestablished in accordance with the Redistricting Ordinance Approved by the Board on April 26, 2011, including the establishment of polling places for each precinct, namely The Baptist Valley Fire Department and L&G Auction House. 3. That all other provisions of the December 6, 2011 Ordinance hereby are repealed and all other provisions of the April 26, 2011 Ordinance shall remain in full force and effect.

CHAMPION STREET – INCLUSION INTO COUNTY'S ORPHAN ROAD SYSTEM

As a result of a public hearing held on March 6, 2012, to wit: "A PUBLIC HEARING TO CONSIDER ACCEPTING CHAMPION STREET INTO THE COUNTY'S ORPHAN ROAD SYSTEM." Champion Street is located off of Claypool Hill Mall Road, on the West side of U.S. Highway Route Numbers 19 and 460, at or near Claypool Hill, Tazewell County, Virginia. The affected owners of adjoining property are HEICO Pty, LLC, H. Paul Buskell & Associates, Donald L. Case, Darlene Case, Donna Case Burnette, Anthony W. Endicott, and Connie J. Jamison. The road serves six structures and extends a distance of approximately Nine Hundred Forty Feet (940 ft.)

Now, upon motion of Supervisor White, seconded by Supervisor Absher and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby accepts Champion Street into the County's Orphan Road System, subject to the approval of executed easement agreements with property owners. Several property owners of Champion Street have potential concerns with the proposed acceptance. The County Attorney, Eric Young stated that he is working with representatives of HEICO Pty. LLC (Heintsman) who owns property on both sides of Champion Street and often crosses the road with heavy equipment. Heintsman feels the acceptance of the road into the county's system might have an adverse effect on his business. The County Attorney stated that the County Engineer met with the property owners and discussed the placement of potential signage or other alternatives to lessen their concerns, as well as various easement agreement options.

ATV ORDINANCE – TO PERMIT ALL TERRAIN VEHICLES ON CERTAIN STATE ROUTES IN TAZEWELL COUNTY

Consideration of adopting AN ATV ORDINANCE – TO PERMIT ALL TERRAIN VEHICLES ON CERTAIN STATE ROUTES IN TAZEWELL COUNTY was deferred to the May 1, 2012 meeting. The Board of Supervisors are waiting for additional comments from the Spearhead Trail and SRRA seeking their input on the ordinance.

Supervisor Brewster also reminded the Board of the **Coal Heritage Day Celebration** - the first day of the Tourist Season in Pocahontas Virginia held at the Pocahontas Exhibition Mine & Museum, Saturday, April 24, 2010 at noon.

COAL AND GAS SEVERANCE TAX -

HOUSE BILL 1233

Eric Young, County Attorney reported the Governor has not yet approved House Bill 1233 amendments to Coal and Gas Severance Tax Ordinance. If approved, the County Attorney will draft an ordinance to comply with the provisions of House Bill 1233, as amended, and upon its enactment.

DOG TAGS & VACCINATIONS

Eric Young, County Attorney, stated proposed changes to the County's ordinance relating to dog licensing and required rabies vaccinations is being considered. He said the county is considering eliminating the male and female distinction on the tags and a recommendation to offer 3-year tags to coincide with the rabies vaccine might be proposed.

TOURISM ZONE ORDINANCE -

ENTERPRISE ZONE ORDINANCE

Jim Spencer, County Administrator, presented copies of maps outlining areas in Tazewell County proposed for Tourism Zones and Enterprise Zones.

Now, in order to promote tourism and to enhance recreational opportunities for residents, and to encourage tourism business investment in Tazewell County, and upon motion of Supervisors hereby authorize and direct the County Administrator to advertise for a public hearing May 1, 2012 to hear concerns regarding a "PROPOSED ORDINANCE TO CREATE TOURISM ZONES IN TAZEWELL COUNTY, VIRGINIA."
