#### SOCIAL MEDIA POLICY FOR TAZEWELL COUNTY, VIRGINIA

Chase Collins, Assistant County Attorney, presented to the Board of Supervisors a Social Media Policy for county employees and officials.

The policy as presented is intended to promote positive use of social media/electronic communication by County employees and also is intended to protect the privacy and dignity of County employees and others, associated or doing business with the County, from any unlawful or unauthorized actions or words effectuated through online conduct on social media by County employees or through a guest post on a County authorized social media website or page and the policy will govern the standards by which information on behalf of the County must be coordinated with and posted to a County authorized social media website or page.

The Board of Supervisors deferred action on the consideration of approval of the Social Media Policy to the May 1, 2018 regular meeting.

#### **COUNTY ENGINEER -- MATT ANDERSON**

Matt Anderson, County Engineer - updated the BOS with the status of various projects. . He gave a building inspection report, the BOS approved \$4,840, i.e. (\$3,226.66 from Western District and \$1,613.34 from Eastern District ) for VDOT bridge inspections, upon a motion Supervisor Lester, seconded by Supervisor Stacy and unanimously adopted. The County Administrator is hereby authorized and directed to issue said warrants in accordance with this action and which said warrants will be converted to negotiable checks by the Treasurer of Tazewell County, Virginia.

He presented a copy of the most recent Transportation Safety Commission Minutes and gave updates on various roads issues and ongoing road work. Other projects included a report on AASC Falls Mills; Project Biscuit; Clear Fork Flood Study and the New GIS Website. He also gave a report of County Projects by District, i.e. Roads; IDA; Landfill; GIS; E&S Control and Permitting; Planning Commission; AASC; Drainage at Paradise Lane; Baseball Sports Complex. (Larry Blankenship) Baseball field Water & Sewer - Public Service Construction; Project Biscuit - sewer extension

# EMERGENCY SERVICES REPORT BARRY BROOKS

Emergency Services Committee - Barry Brooks, Director of Fire & EMS Operations -Updated the Board of Supervisors on the last E & S meeting i.e. Strategic Planning for the next 5 years- introducing a process using internal & external stakeholders from each area to take place in the Strategic Planning; First Responder Training for fire departments were discussed. He said he would invite a representative from VDOT to the next ESC meeting to review a collective plan during emergency issues (used the last snow storm as an example); Communication Committee to be appointed by the ESC Committee. Checks are finally being received for Emergency Services billing. Mr. Brooks also thanked the County inmates for helping clean as well as paint the 945 Community Room; he said "great job."

#### **DAHMON BALL - PSA UPDATE**

Dahmon Ball, PSA Administrator reported on the Greater Tazewell Regional WTP to the Town of Pocahontas Project (Phase IV). The Judge ordered in favor of the PSA /title right of entry possession; bids will be opened in June 2018; Billing started today on the Pocahontas Water project - customers will pay PSA and PSA will transfer money to Pocahontas; Tazewell to Divides Sewer Leachate Line Project 99% complete; Baptist Valley Sewer Project meeting was very productive, approximately 18 people were in attendance; mailings will be sent out to obtain interests; PSA went to Richmond on March 16, funding application for VDH -Pocahontas water distribution center system - should hear something within the next month or so. Debris on Clinch River Sewer Line Crossing issue - high water is preventing clean-up near Rogers Muffler Shop. Supervisor Lester questioned the process of sending PSA complaints he receives. Mr. Ball said to send all PSA complaints to the PSA office and he would respond.

#### JERRY MCREYNOLDS - TAZEWELL COUNTY AIRPORT

Jerry McReynolds, Airport Manager, reported on the large sinkholes at the Airport, engineers will come and do an assessment on the sinkholes. He said after the sinkholes are fixed, the Airport would be in good shape.

#### DAVE WOODARD - COMMUNITY DEVELOPMENT AND TOURISM UPDATE

Dave Woodard gave a Community Development & Tourism update. He presented a hand-out outlining the status of various projects: i.e. preparing for tourist season; double checking for transient occupancy tax; developing mobile visitors center concepts; researching 3 dimensional marketing at the Visitor's Center; working on various grants, Marketing Leverage Program, VTC; Community Foundation of the Virginias; Shott Foundation; grant for a local foundation for MVC and one for Marketing Leverage to VTC; Community Development committee - first lunch meeting scheduled for April 26 at the American Legion Building in Tazewell, VA.

Supervisor Lester requested that the word "County" stand out more in the Welcome to Tazewell County signs. He said the sign in his part of the County appears to say "Welcome to Tazewell".

# CUMBERLAND PLATEAU PLANNING DISTRICT

#### - LIAISON REPORT

Supervisor Stacy reported that Sunset Communications has a new finance partner for the project and a May 2018 closing is scheduled.

Supervisor Stacy requested that Patricia Green contact Jim Baldwin at CPPD and clarify representation on the Virginia Coalfield Coalition (VCC).

#### **BUDGET COMMITTEE FY2018-19**

Supervisor Hackworth and Supervisor Hymes, BOS members of the Tazewell County budget committee reported the budget for fiscal 2018-19 is \$3.4 million short. They have served on the budget committee over the years and said the upcoming budget for FY18-19 is a tough as it gets.

Supervisor Hackworth said the budget committee have been looking at revenues and costs savings. Supervisor Hymes stated that some things the Board have no control over that has caused the budget shortfall, such as the state mandating the purchase of new voting machines at a cost of \$250,000.00, as well as the decline in coal and gas severance taxes.

Supervisor Hackworth said he felt it was incumbent to take immediate action with regard to spending county funds, and, now upon motion of Supervisor Hackworth, seconded by Supervisor Lester and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby suspend all county spending and freeze all new hiring until July 1, 2018, such that no expenditures may be made without approval by the Tazewell County Administrator.

#### SEXUAL ASSAULT AWARNENESS MONTH

Jennifer Bourne, Family Crisis Services Director/Planner, Clinch Valley Community Action, Inc. requested that the Board of Supervisors proclaim the month of April 2018 as SEXUAL ASSUALT AWARNESS MONTH in Tazewell County, Virginia.

Now, upon motion of Supervisor Asbury, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby adopts a adopts a resolution proclaiming the month of April 2018 as Sexual Assault Awareness Month in Tazewell County, Virginia:

#### **PROCLAMATION**

Sexual Assault Awareness Month calls attention to the fact that sexual violence is widespread and impacts every person in this community. Every day, women, men and children across Tazewell County experience the pain and trauma of sexual assault. From verbal harassment and intimidation to molestation and rape, this crime occurs far too frequently, goes unreported far too often, and leaves long-lasting physical and emotional scars. During Sexual Assault Awareness Month, we recommit ourselves not only to erasing the secrecy and shame surrounding sexual assault, but also to raising awareness, expanding support for victims, and strengthening our response.

Whereas, rape, sexual assault, and sexual harassment harm our community, and statistics show one in five women and one in sixty-seven men will be sexually assaulted at some point in their lives (Smith et al., 2017); and

Whereas, child sexual abuse prevention must be a priority to confront the reality that one in six boys and one in four girls will experience a sexual assault before the age 18 (Dube et al., 2005); and

Whereas, on campus, one in five women and one in sixteen men are sexually assaulted during their time in college (Krebs, Lindquist, Warner, Fisher & Martin, 2007);

NOW, THEREFORE, the Tazewell County Board of Supervisors do hereby proclaim April 2018 as Sexual Assault Awareness Month and urge all residents of Tazewell County to embrace their voices to show their support for survivors, to stand up to victim blaming, to promote everyday consent, and to practice healthy communication with kids. The Board of Supervisors hereby join advocates and communities across the country in taking action to prevent sexual violence. April is Sexual Assault Awareness Month, and each day of the year is an opportunity to create change for the future.

Ms. Brenda Lester Sprinkle, a resident of Grundy, Virginia and a former resident of Abingdon, Virginia, said during her moving transition three years ago, she had a flat tire in the Western District of the County, more particularly, Route 19. Following her call to 911, Tazewell County Sheriff Deputy Brian Triplett was dispatched and he assisted her for nearly three (3) hours until her car was back on the road. Ms. Sprinkle stated that she felt like she had found an angel and she would like to honor Deputy Triplett for his kindness and honorable service, and on his behalf, she presented the check in the amount of \$150.00 to be used for one of the Sheriff Deputy Harold Heatley were all present and joined Ms. Sprinkle for a photograph.

### CITIZEN COMMENTS ROGICH ROAD

Travis Bandy, 231 Gillespie Road, Pounding Mill, VA 24609, requested the status of a response from VDOT and Norfolk Southern - with regard to their support of a new railroad crossing for Gillespie Road. The RR tunnel is inundated by ice in the winter and floods in the spring making travel impossible. The Board of Supervisors at a previous meeting requested the Tazewell County Planning Commission to consider taking Gillespie Road into the County's Orphan Road System, ask the County Administrator to prepare a cost estimate for an alternate route for Rogich Road across the railroad tracks, and request the County Administrator to further send a letter of support to the Virginia Department of Transportation and Norfolk Southern supporting a new railroad crossing for the road. The County has not received a report on the request.

#### **CITIZEN COMMENTS**

#### **GARY MOORE**

Gary Moore, Moore Mountain Road, questioned the Board of Supervisors with regard to the \$3.4 million budget deficit. He wanted to know the status of Project Jonah; a proposed meat processing center; the Bluestone Building; the Sol-Smart Energy Program and a proposed ATV Trail from Mudfork to Lake Witten.

Ms. Green, County Administrator responded and said that Project Jonah was still a prospective business; the IDA is looking into the meat processing plant; the Shell Building at the Bluestone was a few days behind because of the weather; the BOS are actively marketing the facility and the RDA continues to work to extend the ATV trails in the Northern District. She said most of the economic development projects are confidential and can't be discussed due to the possible loss of grant funding is made public before completed.
