#### MATT ANDERSON - COUNTY ENGINEER

Matt Anderson, County Engineer, gave a monthly update on the many activities taking place in the County Engineering Department - the report included a Bridge Inspection Report; FEMA Flood Study update; the latest minutes from the Tazewell County Transportation Safety Commission; Landfill updates on GHG Reporting and a Solid Waste Management Plan report; Building Inspection Report; Road Projects; Comprehensive Plan update and Lake Witten Dam repairs; and Bishop Fire dept. - speed study.

#### EASTERN AND WESTERN ROAD FUNDS APPROVED

Upon motion of Supervisor Absher, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves the amount of \$4,520.00 divided as set forth below to do bridge inspections for Fincastle Farm Road, Sage Hill Road, and Mountain Road (the amount of \$1,506.67 from the Eastern District and \$3,013.33 from the Western District Road funds). The County Administrator is hereby authorized and directed to issue said warrant for said bridge repairs and further enter into and Standard Form of Agreement Between Owner and Engineer for Study and Report Professional Services - i.e. Schwartz & Associates, Inc. Lynchburg, Virginia.

#### **CAVITTS CREEK DAM -**

#### DAM VALVE REHABILITATION SERVICES

Upon motion of Supervisor Hackworth, seconded by Supervisor Absher and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes and directs the County Engineer to advertise an Invitation to Bid for Construction Project for dam valve rehabilitation services for the Cavitts Creek Dam, located adjacent to 1177 Cavitts Creek Road, North Tazewell, VA 24630. The low drain valve is inoperable and must be repaired. This work will be in accordance with the conclusions and recommendations of an inspection report conducted for the County in September 2010 and monies are available for repairs in the Capital Projects Fund - Cavitts Creek Dam Upgrades.

**BISHOP FIRE DEPARTMENT** 

#### -AND RAILROAD EASEMENT PROJECT

Upon motion of Supervisor Asbury, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby adopts a resolution requesting VDOT to conduct a safety/speed study on Route 16 adjacent to Route 161 approximately a distance of 525 feet (or where the existing speed limit is/state line) to an operational speed of 35 mph or lower.

And, further, upon motion of Supervisor Hackworth, seconded by Supervisor Asbury and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes and directs that the County proceed with the Bishop Railroad Crossing project for the Bishop Fire Department pending approval of the safety/speed study request by VDOT. A quote from Northfolk & Southern in the amount of \$14,126.00 was given to the County for the Bishop Fire Department - N&S easement.

# MIKE THOMPSON, ECONOMIC DEVELOPMENT DIRECTOR UPDATE

Mike Thompson, Economic Development Director, gave an update on economic development tourism projects. He announced a Entrepreneurial Workshop scheduled for May 3, 2016 9 a.m. to 12 noon American Legion Bldg. Tazewell VA; He will talk about the Enterprise

Zone application later in the year. Mr. Thompson said he was trying to help companies get started and fighting to keep the present companies here.

### JERRY MCREYNOLDS - AIRPORT UPDATE

Jerry McReynolds gave an Airport update by a written report submitted earlier in the day. He gave a brief oral report as well on the West End Drainage project; the annual Air show is scheduled for August 27; the School children visits to the Airport have been scheduled; All hangars are full and the first helicopter will be stationed at the Airport. A copy of the report as submitted is on file in the office of the County Administrator, 108 East Main Street, Tazewell, Virginia.

#### DAHMON BALL - PSA UPDATE

Dahmon Ball gave a PSA update. The CWWTP dedication will be held in the spring; A Natural Gas meeting was held April 4, 2016; Greater Tazewell Project Phases 2 & 3 Hawks Height to Boissevain project should be completed in July 2016; Greater Tazewell Phase 4 - DHCD Guidelines have changed and good news as a result, more money will be applied for a total of \$2 million - depends on competiveness; Tazewell to Divides leachate sewer line - out to bid in August 2016; CPPD Annual Reception was held with County representatives present - announced POWER Grant funding hopefully 10 to 20 million available (communities that relied on coal) Workshop will be held April 14 in Wise -The Board requested a summary of the meeting and application process i.e. what departments would be available for funding (there is no money in federal budget as of yet).

#### BARRY BROOKS - FIRE & RESCUE DIRECTOR

Barry Brooks County Fire & Rescue Director is in the process of organizational development for fire and rescue i.e. Emergency Response Zones; Forming a committee to develop a 5 yr. strategic plan - for fire and EMS; submitted proposed revision to Eric Young for his review; Fire & Rescue Pager update working with Derrick Ruble; Public Private Partnership - working with WVVA & Local Radio (PSA); a Temporary Apparatus Committee for 2016 purchases forthcoming. EMS Committee Guidelines- attendance will be discussed at the next Emergency Services meeting - Eric Young is also working on attendance guidelines for members.

Barry Brooks announced the self contained rating apparatus and stated 12 packs were purchased at \$800 each (very good deal) plus excellent training was provided by the vendor.

#### EMS PERSONNEL LICENSURE INTERSTATE COMPACT RESOLUTION ADOPTED

Following a request by Barry Brooks, Director of Fire and Rescue Services, and upon motion of Supervisor Stacy, seconded by Supervisor Asbury and adopted by a vote of 5 to 0, with all members present voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby adopts the Recognition of EMS Personnel Licensure Interstate Compact Resolution (REPLICA). REPLICA provides EMS personnel an immediate privilege to practice, and allows the exchange of information and data between states about EMS personnel that has never existed before as though they are all one state operating together. The enactment of REPLICA in VA will clarify that EMS privileges exist with member states thereby resolving confusion concerning the ability to practice, use of medical treatment protocols, medical direction, requirements to hold multiple EMS licenses, etc. leading to greater accountability for patient-care-related activities of licenses EMS personnel. A copy of the Resolution in a form as hereby adopted is attached hereto and incorporated herein by reference thereto.

# April 2016 PROCLAMATION

Every day, women, men and children across Tazewell County experience the pain and trauma of sexual assault. From verbal harassment and intimidation to molestation and rape, this crime occurs far too frequently, goes unreported far too often, and leaves long-lasting physical and emotional scars. During Sexual Assault Awareness Month, we recommit ourselves not only to erasing the secrecy and shame surrounding sexual assault, but also to raising awareness, expanding support for victims, and strengthening our response.

Whereas, rape, sexual assault, and sexual harassment harm our community, and statistics show one in five women and one in seventy-one men will be sexually assaulted at some point in their lives (Black et al., 2011); and

Whereas, child sexual abuse prevention must be a priority to confront the reality that one in six boys and one in four girls will experience a sexual assault before the age 18 (Dube et al., 2005); and

Whereas, young people experience heightened rates of sexual violence, and youth ages 12-17 were 2.5 times as likely to be victims of rape or sexual assault (Snyder & Sickmund, 2006);

NOW, THEREFORE, I do hereby proclaim April 2016 as Sexual Assault Awareness Month. I urge all residents of Tazewell County to work together to educate our community about sexual violence prevention, to support survivors, and to speak out against harmful attitudes and actions. Prevention is possible when everyone gets involved. The first step is increasing education, awareness, and community involvement. It's time for all of us to take action to create a safer environment for all. I join advocates and communities across the country in taking action to prevent sexual violence. April is Sexual Assault Awareness Month, and each day of the year is an opportunity to create change for the future.

#### SUNSET DIGITAL COMMUNICATIONS

Tim Long, Ryan Elswick and Paul Elswick, representing SUNSET Digital

Communications, headquarter in Duffield, VA, presented a plan to provide fiber services, i.e. broadband Internet; private data; fiber-optic TV and telephone services to rural communities 
Sunset has offered to purchase the OptiNet Division of BVU that has been approved by BVU

Directors but the agreement is under review by Cumberland Plateau Planning District (CPPD).

Cumberland Plateau hold the right of first refusal on BVU's assets and is negotiating with Sunset as part of completing the agreement. The broadband services as proposed would reach approximately 10,500 new customers in a four county region over the next five years. Sunset Digital has purchased BVU Optinet for \$50 million and has agreed to employ all of the BVU's employees, approximately 75. The Board of Supervisors did not take action on the proposals, but acknowledged that broadband service improves the quality of life for new customers and creates new economic development for the region. However, private and federal grants contracts are involved and the deal has to be approved by multiple municipalities as well as the CPPD who have their own rules and regulations. Sunset Digital is hopeful to have the deal closed by June 1, 2016 so that they do not lose their financial backing.

Major Heatley announced April 18 2016 - 6:00 pm. as State Accreditation Event at Sheriff's Office - Dinner will be served - TCBOS were invited; RSVP by April 13, 2016.

Supervisor Absher questioned the present security measures and said he receives regular complaints from constituents regarding the security at the courthouse, more particularly from developers/builders who carry metal objects as part of their profession. #### BANNER CIRCLE PUBLIC HEARING AUTHORIZED

Upon motion of Supervisor Stacy, seconded by Supervisor Asbury and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorized and directs the County Administrator to advertise for a public hearing to consider accepting Banner Circle into the County's Orphan Road Program.

# RECREATION DEVELOPMENT AUTHORITY (RDA)

Supervisor Asbury announced on-going efforts with regard to the building of cabins at Cavitts Creek - Lake Jack Witten.

Supervisor Asbury announced the ATV - Trail Head Resort will be hiring part and full time people. Applications will be accepted April 12 & 13, 2016.

### INDUSTRIAL DEVELOPMENT AUTHORITY (IDA)

Supervisor Hymes announced that the County no longer owns the Pocahontas High School Building. It was recently bought by a local couple Kim and Rhudy Miller and a couple of their friends. The building will be known as the Indian Inn.

#### TAZEWELL COUNTY BUDGET COMMITTEE -

#### SCHOOL BOARD BUDGET

Supervisor Stacy gave a brief update on the county budget committee and its efforts to devise a budget for FY16-17. The County Administrator said the School Board budget was delivered April 1 and they are requesting 125% of the local required match, which the county has funded for the last few years. They are also requesting an additional \$1,667,602 for debt services. Supervisor Stacy said the School Board knows the County's formula for funding.

Supervisor Hymes remarked on the decline in the coal business and the loss of jobs and as a result the loss of County revenue. He said according to figures received by Patricia Green the county will lose more than \$1,000,000.00 this year in coal and gas tax money. With the reassessment of county property forthcoming, Supervisor Hymes said that values of coal and gas

properties would most likely decline. In addition, bank foreclosures are up and most likely will impact reassessment values. He requested that all county departments get prepared to tighten their belts as the new budget year approaches.
