DAMAGE TO FENCE BY DEER

Supervisor Absher questioned if there was a process of recouping monies for damages to a fence by a deer. He said one of his constituents approached him and wanted to know if the County had some type of recovery fund to help pay for damages to their fence. The County does not have a subsidy like this. The County Attorney suggested his constituents consider checking their homeowners insurance policy to see if it might cover the costs for the fence repair. The Interim County Administrator said there used to be a Damage Stamp Fund to cover costs of damages to farm animals and property caused by big game hunters or by deer or bear, but the fund no longer exists.

ANIMAL SHELTER - NEW FACILITY STATUS

Supervisor White questioned the status of the new Animal Shelter facility. Ms. Green said the County is working on the new adoption center. She reported that the State Veterinarian visited the old and new location of the Animal Shelter facility on August 17 with Dave White. Ms. Green said she was pleased with its progress. The current facility passed State inspection. The Bluewolf Company is moving to its new location with the Animal Shelter Board moving forward with haste on the new center.
