EMERGENCY OPERATIONS PLAN 2010 – PRESENTATION BY DAVE WHITE,

EMERGENCY SERVICES COORDINATOR

Dave White, Tazewell County Emergency Services Coordinator for Tazewell County, gave a brief update on the revised Emergency Operations Plan for 2010. The EOP Plan is a legal and organizational basis for Emergency Operations in Tazewell County and must be updated every five years. It is the responsibility of Tazewell County to have trained and knowledgeable personnel to execute the EOP. All personnel shall complete NIMS and ICS training and the ESC Director (County Administrator) and Coordinator are responsible for the development, administration and maintenance of a comprehensive training and exercise program to fit the needs of Tazewell County. Mr. White stated that training and mock exercises are required annually and all appropriate officials, emergency response personnel and appropriate county employees are required to participate in the mock exercises. Any deficiencies identified by the exercise will be addressed immediately.

Now, upon motion of Supervisor Anderson, seconded by Supervisor Campbell and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby adopts a resolution

approving the REVISED EMERGENCY 2010 OPERATION PLAN FOR TAZEWELL COUNTY, VIRGINIA

WHEREAS, it is the responsibility of the Tazewell County Board of Supervisors to maintain an effective operational government during emergency conditions; and

WHEREAS, Tazewell County is subject to natural and man-made disasters; and

WHEREAS, the Tazewell County Board of Supervisors has directed the Tazewell County Coordinator of Emergency Services to develop and maintain a County wide Emergency Operations Plan (EOP); and

WHEREAS, such a Plan provides for an organized and coordinated response to emergency satiations; and

WHEREAS, the Tazewell County Operations Plan (EOP) was updated in 2010.

NOW, THEREFORE, BE IT RESOLVED, that the Tazewell County Board of Supervisors do hereby adopt the revised Emergency Operations Plan (EOP) for Tazewell County, Virginia; and

FURTHER, BE IT RESOLVED that all county, state and federal agencies and all local, state and National Emergency Services oriented organizations have cooperated in the updating and revision of this Emergency Operation Plan (EOP) for Tazewell County, Virginia.

TAZEWELL CARILION COMMUNITY HOSPITAL – STUDY PRESENTED BY RANDY SWATZYNA- CEO

The Chairman welcomed Randy Swatzyna, CEO of Tazewell Carilion Community Hospital to the meeting. Mr. Swatzyna presented the conclusions of a study of the hospital. An independent consultant prepared the study. The study concluded that the emphasis must shift to outpatient services and reduce, but not eliminate patient care.

Following is a summary of proposed outpatient, inpatient and emergency care at Tazewell Carilion Community Hospital:

- Combine emergency department/hospitalist program, allowing for a more consistent delivery of quality care with enhanced expertise at the bedside
- Upgrade imaging services, including a new CT Scanner, and electronic picture archiving equipment
- Hospital remodeling for clinic care and mid-level providers and rotating specialists

- Merge intensive care unit and medical/surgical unit
- Cost-saving measures not related to patient care include closing the hospital cafeteria and assessing how to best provide patient dietary services

Mr. Swatzyna said it was very difficult to lose service, but in order to keep the hospital open, alternate measures must happen. He reiterated the importance of community understanding and support in order for the plan to work. The changes will take place over an 18month period and Carilion proposes to invest approximately \$2 million in facility and equipment upgrades.

Supervisor Campbell thanked Mr. Swatzyna and said he thought the plan was good and he liked the idea of bridging the gap between the emergency department physicians and the physicians on the floor. He commended Mr. Swatzyna and thanked Carilion for allowing county citizens to continue receiving local hospital care as well as keeping people employed.

Supervisor Hymes reiterated Mr. Campbell's comments and said he was excited about getting the closure issues behind him. He said it was the county's goal to support local businesses through the County's IDA and offered the County's support in moving the new plan forward.

CITIZEN COMMENTS

UNSCHEDULED

Supervisor Hymes briefly addressed the Board of Supervisors intent to revisit the County's current coyote ordinance. Supervisor Hymes, Supervisor White as well as the County Attorney will serve as a committee to work with Farm Bureau representatives to discuss changes to the proposed ordinance. A public hearing on the proposed amendments to the ordinance is planned for this spring.

Ray Howell, Chairman of the Tazewell County Safety Commission spoke from the audience and said the TCSC is taking a progressive approach with regard to county highway projects. He said the Commission continues to oppose closure of the Tazewell Residency and recently forwarded to Cumberland Plateau Planning District the Commission's recommendations regarding top priority highway projects for the Long-Term Transportation 6-year Plan. TCSC Member Heldreth was also present and echoed Mr. Howell's comments. Chairman Anderson thanked Mr. Howell and Mr. Heldreth for their excellent work.

Dallas Sparks, 163 Blackberry Lane, Tazewell, Virginia 24651 thanked Chairman Anderson for giving him a ride to Richmond on Jan. 31. He urged the Board of Supervisors to enact zoning for Tazewell County as quickly as possibly within the guidelines of state and local regulations to avoid state intervention.

COUNTY HAZMAT TRUCK

Following a recommendation from the Emergency Services Committee and upon motion of Supervisor Campbell, seconded by Supervisor Hymes and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves the amount of \$10,000 from the Fire Capital Outlay Account No. 32010-8109 for the purpose of stocking the Hazmat Truck with necessary equipment as presented by the Tazewell County Emergency Services Committee, as well as painting/lettering the truck as CO. HAZMAT and further that the truck be housed at the Tazewell County Fairgrounds/County Garage to be used countywide.

Supervisor Campbell expressed desire for the county to continue looking into vehicle needs for emergency services.

MOUNT VISTA COURT - ORDINANCE OF VACATION ADOPTED

Pursuant to a public hearing held on the 11th day of January 2011 and upon duly advertised notices to the public and notice to the adjacent property owners as required by statute, and upon motion of Supervisor Anderson, seconded by Supervisor Absher and adopted by a vote of 3 to 0, with Supervisor Hymes and Supervisor Campbell abstaining from the vote, the Tazewell County Board of Supervisors hereby adopts the following ordinance, vacating a portion of Mount Vista Court, pursuant to Section 15.2-2272 of the Code of Virginia, (1950), as amended:

WHEREAS, pursuant to §15.2-2272 of the Code of Virginia, (1950), as amended, any subdivision plat or part thereof of may be vacated by ORDINANCE of the governing body of the locality in which the land shown on the plat or part thereof to be vacated lies;

WHEREAS, it has come to the Board's attention that a private fence has been erected within the public right of way along Mount Vista Court; and

WHEREAS, it appears to the Board that requiring that the fence be moved would not be in the best interests of the public; and

WHEREAS, it appears to the Board that *in lieu* of requiring that the fence be moved the public interest would best be served by requiring the owners who erected the fence to purchase the public right of way enclosed by the fence for the assessed value thereof in exchange for vacation of the that portion of the public right of way and to then apply the proceeds therefrom to improving said road; and

WHEREAS the Board has duly advertized its intent to do so, setting forth the description of the portion of the map to be vacated and stating the time, date, and place of the public hearing before the governing body, after which the adoption of the ordinance was to be voted upon, was duly published on the 22 day of December 2010 and the 29 day of December 2010 in the Bluefield Daily Telegraph newspaper having general circulation in the County in which Mount Vista Court is located, all as required by §15.2-2272 of the Code of Virginia, (1950), as amended; and

WHEREAS, the Board finds that the requirements for vacation of portions of the plat as contained in §15.2-2272 of the Code of Virginia, (1950), as amended, have been met;

NOW THEREFORE BE IT ORDAINED, that the Board hereby adopts and approves the following Ordinance, vacating a portion of Mount Vista Court pursuant to §15.2-2272 of the Code of Virginia, (1950), as amended:

The Board does hereby **ORDAIN** That portion of the northern end of Mount Vista Court lying more than eight (8) feet west of the center line of Mount Vista Court, beginning at the Southeast corner of lot number 42 running north to the north eastern corner of lot 40, containing approximately 4,121 square feet or 0.0946 acres, is hereby vacated pursuant to §§15.2-2272 of the Code of Virginia, (1950), as amended; and

Be it further **RESOLVED** that this vacation is conditioned upon the sum of ONE THOUSAND, ONE HUNDRED AND SEVENTY FIVE DOLLARS (\$1,175.00) being paid to the County of Tazewell, pursuant to Section 15.2-2008 of the Code of Virginia; and

Be it further **RESOLVED** that the County Attorney hereby is directed to record this ordinance in the Tazewell County Circuit Court Clerk's Office listing Michael T. Hegstrom and Stephanie Hegstrom, the owners of parcels 041A0020, 0040, 0041 as Grantees upon receipt of

VACO's – REQUEST FOR SPECIAL ASSESSMENT (\$3,000.00)

DEFERRED

VACO's request for Special Assessment for \$3,000 was deferred to the March 1, 2011 regular meeting. This issue involves protecting the current burden of proof process in real estate and property assessment appeals. If new legislation is passed, the costs of appeals will be shifted to localities. VACo is requesting each County to consider a special assessment of at least \$3,000 to help with costs associated with protecting the current standard of proof in real estate and property assessment. The Board requested that the County Administrator check the status of the proposed legislation (bill) as well as determining neighboring county participation.

ZONING COMMUNITY MEETINGS

Member White gave a brief update on the three (3) zoning workshops held in the communities of Baptist Valley, Thompson Valley and at Southwest Virginia Community College (SWCC). The zoning workshop scheduled for Springville Elementary School was cancelled due

According to Supervisor White and Absher, the most disapproval of the zoning proposal came from county farmers. Supervisor White encouraged continued community input and requested that Planning Commission members be involved in the zoning process and community meetings. Supervisor White reiterated that the intent of the zoning ordinance was not to restrict people's rights, but to protect them. It was further noted that County staff as well as least five (5) community meetings in various areas of the County, Jewell Ridge, Burkes Garden, etc. The Board of Supervisors also requested that members of the Tazewell County Farm Bureau be included in the zoning process as well.

TOURISM ZONES UPDATE

Chairman Anderson mentioned the need to move forward with Tourism Zones for Tazewell County, particularly in combination with the Spearhead Trail in the Northern District. He said the board needed recommendations with regard to areas for Tourism Zone incentives as well as costs. The County Administrator, in conjunction with this topic, mentioned the proposal for Tazewell County welcome signs. Supervisor White stated that the Tourism Committee is prepared to present several options regarding the welcome signs to the Board of Supervisors at the March 1, 2011 meeting. Supervisors Hymes said he wanted to see a logo contest among schoolchildren and county residents, similar to the contest for the County seal (exempting commercial businesses). The Board agreed to appoint Supervisor Hymes and Supervisor Campbell to the Tourism Zone Committee to come up with reasonable locations for Tourism Zones as well as costs involved.

CANCER LETTERS TO STATE & FEDERAL OFFICIALS

Supervisor Campbell requested that the County Administrator proceed with letters to State Legislatures and Federal officials asking for cancer studies/statistics in Tazewell County. He also requested letters of receipt/acknowledgments apply as well. Supervisor Campbell reiterated his pro-active approach in obtaining information about the many cancer victims in Tazewell County, especially among the youth. Supervisor Hymes concurred with Supervisor Campbell's comments noting the need for responses.

REDISTRICTING UPDATE

Supervisor White announced that the newly established Tazewell County Redistricting Committee would conduct its first meeting February 10, 2011 at 5:30 p.m. in the Tazewell County Administration Building, 108 East Main Street, Tazewell, Virginia. The committee will meet to elect a Chairman, Vice Chairman and Secretary.

GIS RFP INTERVIEW COMMITTEE

Upon motion of Supervisor Hymes, seconded by Supervisor Absher and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby appoints Supervisor Anderson and Supervisor White GIS committee to work with the County Administrator and staff to rank, evaluate and study the RFP-Professional Consulting Services for updates to the County GIS System, Maintenance of the County's GIS System, the Redistricting of Tazewell County's Voting Districts and other GIS related projects that may arise during the term- and based on the ranking, the GIS Committee is hereby authorized to go forward and enter into a non-exclusive agreement with the highest ranked firm, on behalf of the Tazewell County Board of Supervisors.

EQUIPMENT AND OPERATORS BID (MAINTENANCE CONTRACT) TAZEWELL COUNTY & TAZEWELL COUNTY PSA

The County Administrator, Jim Spencer, reported that the County solicited bids from interested firms to furnish equipment together with operators, labor and necessary supervision to perform various projects throughout Tazewell County on an as needed basis, for a contract term of twelve (12) months. The County received three (3) bids; Eric Gardner; Bailey & Wells, Inc. and Hunter Paving, Inc. Gardner was the lowest responsive bidder. Gardner bid is as follows:

Now, upon motion of Supervisor Campbell, seconded by Supervisor Hymes and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby accepts and awards the FY2011 Maintenance Contract for Equipment and Operators to Gardner, Inc. PO Box 111, Vansant, VA 24656 to perform various projects throughout Tazewell County, Virginia on an as needed basis. The bid as submitted shall include the hourly rate for each piece of equipment (including fuel) as well as its operator, mobilization to and from the site, and supervision. The terms of the contract will be for 12 months, effective immediately.

HB 2367 THE VERIZON TELECOM BILL – RESOLUTION OPPOSED

Upon motion of Supervisor White, seconded by Supervisor Hymes and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby adopts a resolution opposing HB 2367, the Verizon Telecom Bill. The legislation, if passed, "would allow telecom companies to raise rates and skimp on telephone line maintenance, meaning Virginia customers could end up paying more and getting less service."

HB 1766 METH LAB PENALTIES – RESOLUTION OF SUPPORT

Upon motion of Supervisor Campbell, seconded by Supervisor Hymes and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves a resolution in support of HB 1766 METH LAB PENALTIES.

HB 884 AND SB 1340 -

ELECTION LEGISLATION

Upon motion of Supervisor White, seconded by Supervisor Campbell and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby adopts a resolution supporting Senate Bills 884 and 1340 permitting the County to purchase replacement DRE voting machines and additional DRE voting machines as needed to supplement our current inventory; so that all voters throughout the County use the same equipment and that election workers may continue to use equipment with which they and the voters now are familiar.

HB 1588

The County Administrator reported on HB 1588. This issue involves protecting the current burden of proof process in real estate and property assessment appeals. If new legislation is passed, the costs of appeals will be shifted to localities. VACo is requesting each County to consider a special assessment of at least \$3,000 to help with costs associated with protecting the current standard of proof in real estate and property assessment. The Board requested that the County Administrator continuing checking the status of the proposed legislation (bill) and reach out to Delegate Morefield for help. According to the present status of the bill, it was sent to the House for amendments.

CAMP 31 -

D.O.C. FACILITY

Supervisor White stated that he spoke to Delegate Will Morefield and encouraged his support relative to Tazewell County's request for the State/DOC to convey the Camp 31/DOC facility to Tazewell County.

JEWELL RIDGE COMMUNITY -

CONVENIENCE AREA

Supervisor White reported that the County Attorney, Eric Young continues to do title work on the proposed convenience area in Jewell Ridge.

RESOLUTION –

APPROVING FUNDING SERIES 2003D, A PORTION OF THE PROCEEDS OF WHICH REFUNDED THE COUNTY OF TAZEWELL, VA – GENERAL OBLIGATION SCHOOL BONDS, 1993 SERIES C AND REFUNDING SERIES 1994;...
