LIAISONS REPORT – BOARD OF SUPERVISORS

Industrial Development Authority (IDA)

Supervisor White reported that the Dental School Project is moving forward as well as the Western District Natural Gas project.

Recreation Development Authority (RDA)

Supervisor Childress reported that the Recreation Development Authority (RDA) met this date and addressed the Pocahontas Walking and ATV Trail. Member Childress stated the County continues to discuss the urgent need for the Land Use Agreement with Pocahontas Land Company. The County held a conference call with VDOT recently with the County Administrator informing them that the Board of Supervisors approved to pay the costs of surveying the walking trail as required by VDOT.

Supervisor White said he was very excited about the opening of the Spearhead trail and has heard positive comments from people outside of Tazewell County, including enthusiasm from a resident in North Carolina about the opening of the trail.

PPEA Guidelines: Cabins/Lodging Facilities and Restrooms – the County Administrator reported that the RDA will procure camping amenities through PPEA Guidelines at the Boissevain Park. The next RDA meeting is scheduled for July 25.

TAZEWELL COUNTY PUBLIC SERVICE AUTHORITY (PSA) SEWER LINE EASEMENT – BAPTIST VALLEY FIRE DEPT.

Upon motion of Supervisor Stacy, seconded by Supervisor Childress, and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves and authorizes the execution of a RIGHT OF WAY EASEMENT AGREEMENT – BETWEEN THE TAZEWELL COUNTY BOARD OF SUPERVISORS AND THE TAZEWELL COUNTY PUBLIC SERVICE AUTHORITY – FOR A SEWER LINE EASEMENT LOCATED IN BAPTIST VALLEY VIRGINIA – FOR THE BAPTIST VALLEY FIRE DEPARTMENT PROPERTY/BAPTIST VALLEY PRECINCT. (CVCA) Board of Directors, for a term of one (1) year commencing July 1, 2013 and expiring June 30, 2014.

CUMBERLAND PLATEAU PLANNING DISTRICT (CPPD)

One (1) appointment to the Southwest Regional Recreation Authority was deferred to the next regular meeting. The RDA formed a committee at their June 27, 2013 meeting to make a recommendation to the Board of Supervisors with regard to this appointment. Margie Douglas will continue to serve in this capacity until the appointment is made.

TOURISM SIGNS

The County Administrator reported that a demo of the "Welcome to Tazewell County" signs will be presented August 6, 2013.

POCAHONTAS WALKING/RIDING TRAIL

The County Administrator recapped an earlier report by Supervisor Childress concerning the Pocahontas Walking/Riding Trail and payment by the County for cost of surveying as required by VDOT. Mr. Spencer notified Hill Studio of the June 4, 2013 action by the Board of Supervisors regarding payment of same.

EMERGENCY SERVICES – EMS REGULATIONS/DESIGNATED INFECTIOUS CONTROL OFFICER

The County Attorney, Eric Young, reported that the required EMS-Designated Infectious Control Officer can be the same person for multiple departments. The County Administrator said that Dave White is working to hopefully schedule training to host here in Tazewell County. The EMS – DICO, officer, will be responsible for responding to emergency fire and medical scenes where Fire Service Paramedics and Firefighters have suffered potential exposures to infectious disease, investigates and evaluates the exposure incident, directs the appropriate actions and monitors all follow-up treatment based on applicable departmental regulations and protocols and Federal, State and local laws and regulations.

BOARD CONCERNS

Supervisor White invited those present to the Freedom Festival scheduled for Saturday, June 29, 2013 in Richlands. He said there would be many activities including fireworks.

Supervisor Hymes announced that he was very happy to report that Dr. Brenda Lawson responded to the County's letter with regard to the retirement of Bob Moss, Agriculture Instructor at THS. Supervisor Hymes said Dr. Lawson informed the Board that the School Board was committed to retaining Mr. Moss's position, noting the importance of agriculture in Tazewell County. Supervisor Hymes thanked the Farm Bureau for bringing this concern to the Board of Supervisors, noting the importance of the School Board's official response.

TOURIST INFORMATION KIOSK

- CRAB ORCHARD MUSEUM

Upon motion of Supervisor Hymes, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby declares as County surplus the Tourist Information Center – Kiosk, located on property near the Historic Crab Orchard Museum, Tazewell, Virginia and hereby offers the Kiosk to the Crab Orchard Museum. Should the Crab Orchard Museum reject the County's offer, the Kiosk shall be moved and used at the Lake Jack Witten/Cavitts Creek Park.

CITIZEN COMMENTS SWCC CONCERNS – TONY LOTITO

Tony Lotito, former employee of SWCC, coordinator of off-campus classes for 40 years – spoke to the Board with regard to comments made by Dr. Mark Estepp at the June 4, 2013 meeting of the Board of Supervisors. Mr. Lotito said that he was invited to the meeting by several members of the board of supervisors to respond to the Dr. Estepp's remarks.

Mr. Lotito gave a brief history of the college. He said at one time the college was the fifth largest and viewed as the "shining star" of community college systems. He presented charts and figures and raised questions with regard to low enrollment at the SWCC as well as questioning the college's financial condition. Mr. Lotito voiced concern with Dr. Estepp's - June 4 comments to the Board of Supervisors in regard to SWCC only having \$15,000.00 in the bank. Mr. Lotito alleged that when he left the college there was over seven (7) figures in funding and said the Board of Supervisors as contributors, need to know where the money was going and questions should be asked. With regard off-campus classes he said the number has continued to go down. Mr. Lotito said that could coincide with the decline in the college's finances. Mr. Lotito also voiced concern that students could not find schedules for off-campus courses because the classes are not put on the calendar. He reiterated the colleges pledge to offer as much postsecondary education as they could, and turn no one away, even if they could not pay. Mr. Lotitio said he was disturbed that Dr. Esteep did not know how many credits are required for a FTE - primary funding for the college. He said the FTE figure varies from college to college and the college president is the one that negotiates the rate. Mr. Lotito said his position was eliminated and his department brought millions in funding to the college. He was told that his department did not have enough qualified SACS accredited teachers and if the teachers are not accredited a "rationale" can be written explaining why they should still be allowed to teach. He said the college got a warning and the students are suffering because of the warning.

With regard to faculty, he said there were 40 percent fewer faculties with the programs that have been eliminated. He said one health care program had been eliminated with the radiology department on probation. Mr. Lotito said he felt the college was struggling and for the first time in its history has been put on academic warning. He requested that the Board look into the issues as presented and ask that Delegate Morefield and Senator Puckett form a committee to

look into how the college is being managed. Mr. Lotito further said he believed there was enough evidence for an investigation, indicating something was not right and it needed to be made right. Chairman Absher said he liked Dr. Estepp but he's seen a lot happen at the college and the Board needed to look out for Tazewell County. With this said, Supervisor Absher moved to request that local legislators ask for an internal investigation of the college, with Supervisor Childress seconding the foregoing. Discussion ensued. Supervisor Stacy said the board should invite Dr. Estepp back and let him respond to Mr. Lotito's remarks – as a defense he said Dr. Estepp should be given an opportunity to speak on what was said this evening. Supervisor White agreed. Now, Supervisor Absher moved to withdraw his motion, with Supervisor Childress withdrawing his second. The Board suggested that Dr. Estepp be invited to the August 6 meeting.

Now, with regard to this topic, former Sheriff, Bill Osborne spoke and told the board they needed to be careful how they handled the situation. He said with all due respect to Mr. Lotito, he felt the college's enrollment went down when the police training center was moved to Bristol. He said the training center brought attention to other classes and police training participants enrolled in additional classes at the college. Mr. Osborne said he felt Dr. King made a big mistake to let the training center get away because every police officer in Southwest Virginia went to SWCC for training, and reiterated that a part of the college was lost when the police training school closed. He said the SWCC has done a lot for Tazewell County, stating we now live a very depressed area.

CITIZEN COMMENTS – UNSCHEDULED

Mr. Roger Mitchem, 1122 Big Branch Road, Bluefield, Virginia 24605, spoke to the Board about the costs involved to build Route 696. Mr. Mitchem said he requested that the Board provide him the costs, to the penny, that the County spent on the construction of the Big Branch Road/Route 696. He also voiced dismay with how people were being treated on Big Branch Road. He said he could not run cattle across the road because of the dangerous curves and lack of signs. He wanted to know why the road was never widened. He also spoke of the Pocahontas Trail and mentioned the high costs of charging people \$100 to \$150 dollars a night to stay in such small quarters. Supervisor White said those fees were being charged by WV officials, not VA. Supervisor White said in the near future the Pocahontas Trail would be the

best thing that ever happened to the Northern District with regard to Economic Development and Tourism. The County Attorney said that he would send Mr. Mitchem, within 5 days, the County's costs involved relative to the construction of Route 696.

PUBLIC HEARING -

PROPOSED ORDINANCE AMENDING THE COUNTY'S TAX ORDINANCE

The Chairman of the Board of Supervisors called to order a public hearing that was duly advertised according to law, entitled, a PROPOSED ORDINANCE TO HEAR CONCERNS REGARDING AN "ORDINANCE AMENDING THE COUNTY'S TAX ORDINANCE TO ALLOW THE COUNTY TO RECOVER FROM DELINQUENT TAX PAYERS AN ADDITIONAL 20% OF UNPAID REAL ESTATE TAXES FOR PAYMENT OF ADMINISTRATIVE FEES, ATTORNEY FEES, AND COLLECTION AGENCY'S FEES TO COVER THE COSTS ASSOCIATED WITH THE COLLECTION OF DELINQUENT TAXES." A complete copy of the ordinance as advertised is on file in the office of the County Administrator and posted at the front door of the County Courthouse in the office of the Circuit Court Clerk, on Main Street in Tazewell, Virginia.

The Chairman then called for public comments from the floor. The County Attorney, Eric Young, explained the Board of Supervisors currently has no provision in place regarding payment of Administrative Fees, Attorney's Fees, and Collection Fees for the collection of delinquent taxes. He said the County is proposing to charge a 20% fee of unpaid real estate taxes-- such fee will be imposed no earlier than 30 days after notice of the delinquency has been sent to the taxpayer and shall be equal to the maximum amounts allowed by the Code of Virginia. Supervisor White suggested the County consider revising the ordinance giving additional time. He felt the 20% fee was too unsympathetic for the average person who might be 30 days late on paying their taxes. The County Attorney along with the Treasurer, Dave Larimer explained that the Code of Virginia sets the time-frame, a two-year statute, before the County can sue a property owner for the sale of its real-estate property that is delinquent in the payment of its taxes. Mr. Larimer also explained that the 25% fee in the ordinance would be charged for payments for outside/contracted agency work because the County Attorney's office and staff as well as his office are already on the County's payroll. The County Attorney stated

that he would change the language in the ordinance to be more clear with regard to the 2-year statute as well as for the collection of fees to cover costs of out-side agency work.

Now, the Chairman called for further comments from the floor and there being none, he declared the public hearing closed.

The ordinance will be considered for adoption at the August 6, 2013 regular meeting.

BOBBY SHEW FOUNDATION – POCAHONTAS

Supervisor Childress moved to amend the proposed budget by including \$2,000.00 in the amended budget for the Bobby Shew Foundation, subject to legal review, to determine if the Bobby Shew Foundation is a charitable organization/501c3. Supervisor Stacy seconded by foregoing, but the motion was later withdrawn. Rev. Darrell Hundley was present and said the Bobby Shew Foundation was a Sub-501c3 of the Baptist Church. The Board said they could not expend monies to a non-501c3 organization. Supervisor Childress said that he has monies allocated in his district fund allocations for FY13-14. Following discussion it was decided to address this matter later in the meeting.

Now, the Chairman of the Board proceeded with the agenda format regarding the adoption of the proposed county budget.

BUDGET AMENDMENTS APPROVED

Upon motion of Supervisor Stacy, seconded by Supervisor Hymes and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves the amendments to the proposed advertised budget as were outlined and discussed previously.

SCHOOL BUDGET –LOCAL FUNDING APPROVED FOR FY13-14

Following discussion of local funding for the Tazewell County School Board for FY13-14, with Steve Davis, Chairman of the School Board in attendance, and upon motion of Supervisor Stacy, seconded by Supervisor Childress and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves the amount of \$14,750,000.00 as local funding for the Tazewell County School Board Budget for FY2013-14.

And, further, upon motion of Supervisor Stacy, seconded by Supervisor Hymes, with all members present voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves the amount of \$266,000.00 to be placed in the County's Capital Projects Fund to be disbursed as one-time debt service payments on behalf of the Tazewell County School Board.

Board of Supervisor members requested that school board members be notified that the \$266,000.00 was a one-time payment and would not be included in next year's budget.

Supervisor White requested that over the next 60 days the School Board review their budget and to come back to the Board of Supervisors with several proposals and ideas and ways to work toward incentives to save money within the school system – including the possibility of the County helping to pay for retirement for early school retirees who are eligible and at the top of the pay-scale. Steve Davis, School Board Vice Chair was present and agreed that infrastructure and planning was needed. He commented on the allocation approved for the school board this date, and said the amount would help even though the amount was less than the school board requested. He said some cuts would still need to be made. The Board suggested that a committee be formed accordingly to address school board funding incentives for years ahead.

BUDGET AMENDMENTS APPROVED

Now, discussion was held regarding the proposed amendments to the proposed County Budget Ordinance, FY2013-14.

Now, upon motion of Supervisor Hymes seconded by Supervisor Childress and adopted by a vote of 5 to 0, with all members present voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves the Tazewell County Budget amendments to the proposed Tazewell County Budget Ordinance as hereby recommended by the Tazewell County Budget Committee. The Chairman called for a recess of five (5) minutes after which the meeting was duly reconvened.

PLANNING COMMISSION REPORT

Supervisor Childress reported that the Planning Commission at their June 13, 2013 meeting discussed the Board of Supervisors request for the County to take Ponderosa Road and Sage Hill Road located in the Western District into the County Road Program. The Engineer's office as well as 2 members of the Planning Commission went to the road sites and reviewed the road conditions. Following a review of both roads by the road sub-committee it was recommended by the Planning Commission that the County not take the roads into the County's Orphan Road System.

Supervisor Childress also reported on behalf of the Planning Commission that the Planning Commission again offered to manage the County's Orphan Road Program and make the decisions on roads being taken into the system. Even then, residents on a road would have the right to appeal a decision of the Commission to the Board of Supervisors.

Supervisor Hymes said he did not agree to this method and said he thought the Board of Supervisors should be the ultimate decision maker with regard to road repairs. Supervisor Stacy agreed with Supervisor Hymes remarks and suggested a recommendation be given only by the Planning Commission. Supervisor White said he appreciated the Planning Commission's

assistance by looking at the roads and making comments, but felt the idea needed additional study.

The Commission also made a recommendation that a standard petition be drafted requiring all property owners to sign prior to a particular road or street being considered for inclusion in the orphan road program.

With regard to the proposed zoning, Supervisor Stacy requested that the Planning Commission proceed with a time-line with regard to Zoning for the Eastern District.

The Comprehensive Plan Sub-committee recently met and discussed the transportation portion of the plan and will address community facilities at their next sub-committee meeting.

With regard to drafting a proposed Peddlers Ordinance for Tazewell County, it was suggested that this situation be remedied by existing laws. Supervisor Childress said he was working with the Commissioner of Revenue and other county departments to see that peddlers as well as pawn dealers abide by county and state laws. Supervisor Childress said he would keep the Board apprised of further details on these topics.

BOARD CONCERNS

Supervisor Hymes reported that a rumor was circulating in his district that two (2) prospective industries were turned down by the County to construct a building in the Bluestone. The County Administrator reported that there have been no solid offers for the purchase of property in the Bluestone.

Supervisor Hymes wanted to know the County's plans for the old cheese house at the County Fairgrounds. The County Administrator said the County is planning on fixing the building up to be used as storage for county maintenance.

Supervisor Hymes wanted to know the status for Yong's Restaurant. The County Administrator said a local business person would be submitting a business plan to the IDA.

FAIRGROUNDS SEWER LINE /

WATER LINE

The County Administrator reported that the sewer-line is completed at the County Fairgrounds. The water-line is the next project. The County's goal is to complete the installation within 30 days before the County Fair begins. The Board of Supervisors suggested that the County request that the County PSA help the County in the installation of the water-line to speed up the project as well as a costs saving measure. The County Administrator said the PSA's expertise would also be valuable in speeding up the completion of the water-line.

BUILDING AND MAINTENANCE BUDGET – HISTORICAL SOCIETY PROJECT FUNDS NECESSARY FOR PLACEMENT OF PLAQUES ON COUNTY BUILDINGS AND STRIPING OF PARKING LOT

Supervisor Hymes reported that the Tazewell County Historical Society would be placing plaques on various buildings in the Town of Tazewell; four (4) of the buildings belong to the County, Bldg. Nos. 15,16,17 & 18. The County Administrator also reported that the rear parking areas of the County Administration Building needed to be striped to alleviate illegal parking where on various occurrences vehicles have been blocked in. It was the consensus of the Board of Supervisors to proceed with the placement of the plaques on County Buildings as well as striping of the parking lot – monies will be taken from the County's Building & Grounds

Budget, Account No. 43020-3310 Repairs & Maintenance. The County Administrator is hereby authorized and directed to issue said warrant as may be necessary and appropriate to the Tazewell Historical Society for the placement of plaques – cost of the plaques will be approximately \$1,000.00 for the four (4) county buildings. The County Administrator said the building inspectors must abide by and enforce all building code requirements, however, the County Administrator said he would speak to Gary Jackson, Chief Building Inspector about the situation.

CERTAIN AREAS IN CLAYPOOL HILL

POSSIBLY BE CONSIDERED INTO ENTERPRISE ZONE

Supervisor Absher requested that certain areas in Claypool Hill be considered for inclusion in the County's Enterprise Zone, more particularly areas located near the Timberline Motel and other properties near the bowling alley might be considered as well. The County Administrator reported that properties could only be added once per year; and it must be more than one (1) parcel. The ordinance can be considered for changes in December 2013.

Supervisor Absher moved to close the county offices on Friday July 5, 2013 in order to give County employees an additional day off in observance of the July 4 holiday. The motion died for a lack of a second. Supervisor Stacy wanted to know how much closing the county offices an extra day would cost county taxpayers. Supervisor White said he felt the County needed to be open, as well as the courthouse. He said his job as well as other banking institutions depends on the Courthouse to do business.

No decision was made on giving County employees an additional day off at this time.
