Upon motion of Supervisor Stacy seconded by Supervisor Brewster and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves amending the Regional Jail Lease to include a portion of the space in the courthouse previously occupied by the Tazewell County's Sheriff's office and to relocate the Registrar's office into another portion of the former sheriff's office space as shown in the lease agreement amendment as attached hereto and incorporated herein by reference thereto.

# CITIZEN COMMENTS LPN PROGRAM – ELIMINATION BY TAZEWELL COUNTY SCHOOL BOARD

The following individuals spoke in reference to the elimination of the Tazewell County School System's LPN Program:

"My name is Davina Hieatt. I have been a registered nurse for almost 16 years. I currently hold a Bachelors degree in Business Administration and I am currently employed as the Director of nursing for Heritage Hall in Tazewell. I have spent 15 of my 16 years as a nurse in the long term care industry. I have spent three of those years traveling throughout the state in other long term care facilities throughout the state. I currently employ 31 LPN's. I tell you all of that to say this. Contrary to popular belief Licensed Practical Nurses are not a dying career. Out of the 31 LPN's I employ, 25 of those LPN's graduated from the Vocational school LPN program. I previously had twenty six, but one went on to successfully complete the RN program and just recently passed her Virginia state boards to become a Family Nurse Practitioner. One of those LPN's is currently my Assistant Director of Nursing. She is third in command of the entire facility. Our facility is the largest long term care facility in this entire area at 180 certified beds. I also currently employ four Registered nurses who initially graduated from this LPN program. They are all currently in Nursing administration. Many of these LPN's were previously Certified Nursing Assistants and after successful completion of the program they went on to stay in the area and work as LPN's. This just speaks to the quality of the nurses that this program sends out into the workforce in our area. The nurses that I employ I believe are of the highest caliber. They are very professional, they are very knowledgeable. It is very difficult to hire a new nurse when they have had no clinical experience or classroom training, and believe me I have had some of those as well, but never from this program. I have no reservations about hiring LPN's from the vocational school program. They have a 100% pass rate on their state boards. That is very important from a financial standpoint because it is very costly to invest in all of the orientation and training of a new nurse only to have them fail their state board. It has also been my experience when hiring nurses from outside this program that failing their state boards is very common, almost expected, so much so that I am very hesitant to even hire nurses from outside this program until they have successfully passed their state board. It is also not uncommon for them to fail them more than once. The LPN's from this program virtually need no training at all in general nursing practice. They can start IV's, insert Foley Catheters, treat wounds; their assessment skills are unparalleled, as is their documentation skills."

"My name is John Quintier, Administrator at Heritage Hall Nursing and Rehabilitation Center located in Tazewell, VA. I have been a licensed Administrator for 15 years and also have a Nursing Home Administrator's license in West Virginia and Ohio. When I first heard that there was a possibility that the LPN program at the Vocational School was in danger of being eliminated, I immediately contacted Davina Hieatt, Director of Nursing to get the specifics on the dynamics of the issues that contributed to this decision. Heritage Hall is a 180 bed long term care facility that employs 160 staff members. The Heritage Hall payroll is approximately \$150,000 every two weeks. When contracted Therapy Services are added, the facility provides employment for almost 200 people and has a monthly payroll of almost \$400,000 per month, every month, 12 months per year. LPN's are a valuable part of the facility's operation. Currently, the facility employs over 30 LPN's and the success of the facility is dependent on the knowledge and expertise of these staff members. After speaking with Davina, I learned that over 80% of our licensed nursing staff obtained their certification through the Nursing program at the Vocational School and went on to sit for the state boards and obtain their nursing license. Heritage Hall is one of the largest employers in the county, and recruiting, training and employing LPN's is a vital part of our objective. If the Nursing Program at the Vocational School is eliminated, it would be a definite obstacle for the facility to continue to recruit and employ local individuals

who are interested in a career in Health care. These are ready made jobs in the fastest growing, most consistent industry in our area. Please accept this letter as a request to seriously consider the ramifications of eliminating this program. This decision will affect the health care providers in the area as well as the overall employment opportunities in the entire region. So many of our young people move out of the area to find employment elsewhere, and the elimination of this program would only result in more of our population moving away or becoming reliant on other government services to cover basic needs because of lack of opportunity."

## Supervisor Brewster's Comments Regarding LPN Program

"Over the past three years, the Licensed Practical Nurse (LPN) licensing program has produced thirty-five (35) highly qualified candidates to assume skilled positions in the area of healthcare throughout Tazewell County. The care and well being of our local population, especially the increasing elderly community, should of concern to all. With life expectancy increasing and the baby boomer population coming of age, this will be an area that could face critical shortages for quite some time. By 2016, jobs for LPNs are expected to grow by fourteen (14) percent. Our LPN program provides skilled training and certification for both our student and adult populations. Once they complete this program, they will see increases to their earning and spending power. Let us not forget how they contribute to the communities where they live. These students also have the opportunity to secure jobs and live right here in Tazewell County. Since 1949, the LPN licensing program has had a strong reputation for producing highly skilled and caring healthcare providers. To lose this program now would cut the pipeline to both future employment opportunities for our residents. Furthermore, the loss would prohibit future continuing advancement, limit educational and (re)training opportunities for our adult learners, and leave our employers looking outside of Tazewell County to secure a much needed work force. What makes the elimination of the LPN Program different from the other school budget cuts is that the LPN program provides workforce training for our adult learners and a certified workforce for our community partners. I am asking my fellow Supervisors to assist me in securing the partnerships needed to continue to operate this program at a high level. I am calling for the immediate formation of a task force of healthcare professionals to assist the Board with making a final decision relevant to the continuation of this program. The task force should have recommendations prepared for the Board's next meeting."

Upon motion of Supervisor Brewster, seconded by Supervisor White and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby suspends Roberts Rules of Order regarding the June 28, 2012 agenda format in order to take up other agenda matters as may properly come before the Board of Supervisors prior to holding the public hearing on the Proposed Real Property Tax Increase.

# RESOLUTION TO RECONSTITUTE THE MEMBERSHIP OF THE TAZEWELL COUNTY TOURISM DEVELOPMENT COMMITTEE

**WHEREAS** Virginia Code § 15.2-5505 requires that each locality in the Cumberland Plateau Planning District establish a local tourism development committee to develop tourism plans for the locality and the regional Tourism Development Authority;

**WHEREAS** Tazewell County has established the Tazewell County Tourism Development Committee by previous resolution pursuant to Virginia Code § 15.2-5505;

**WHEREAS** Virginia Code § 15.2-5505 further requires that the Tazewell County Board of Supervisors appoint five members to serve on the Tazewell County Tourism Development Committee;

**WHEREAS** the Board finds it appropriate to give advisory assistance to the five members of the Tazewell County Tourism Development Committee.

#### NOW THEREFORE, BE IT RESOLVED,

That, effective immediately, in accordance with Virginia Code § 15.2-5505, the Tazewell County Board of Supervisors resolves that the Tazewell County Tourism Development Committee shall be composed of five (5) members, being one member from each district, who shall constitute the entire committee membership for purposes of planning any regional Tourism Development Authority project or for any purposes set forth in Virginia Code § 15.2-5505 *et seq*.

That, effective immediately, the following additional members shall serve with the above-mentioned members in an advisory capacity to the Committee and the Board of Supervisors. Such additional members shall be permitted to cast votes and their votes shall be reported to the Board of Supervisors. However, for purposes of any function pursuant to Virginia Code § 15.2-5505, only the five statutory members' votes shall be counted. Such additional members shall have the right to make and second motions; participate in public discussion; and otherwise perform as members of the committee

(1) The President of any Chamber of Commerce serving any incorporated town within Tazewell County, or his or her designee.

(2) The president of the Tazewell County Farm Bureau or his or her designee.

(3) The Tazewell County Administrator or his or her designee shall constitute one (1) *ex officio* member.

All members of the committee shall have two year terms, and shall be allowed to succeed themselves in the position.

# CITIZEN COMMENTS – UNSCHEDULED REAL PROPERTY TAX - PUBLIC HEARING

The Chairman, D. Michael Hymes called the public hearing to order entitled: Notice of Proposed Real Property Tax Increase - The Tazewell County Board of Supervisors provides the following notice commensurate with 2011 general reassessment, pursuant to Section 58.1-3321 of the Code of Virginia. The 2011 Reassessment includes reassessment of gas wells by a different method than the method used in the previous assessment, resulting in a potential, significant increase in revenue from gas wells. The County expects litigation from the gas well owners contesting the new assessment method. The outcome of the litigation would be uncertain. To avoid budget shortfalls, in the event the gas well owners are successful in contesting the reassessment method, the Board also will consider revenue estimates <u>excluding</u> the gas well increase. Those numbers are set forth separately.

# NOTICE OF PROPOSED REAL PROPERTY TAX INCREASE

The County of Tazewell proposes to increase property tax levies.

1. Assessment Increase: Total assessed value of real property, excluding additional assessments due to new construction or improvements to property, exceeds last year's total assessed value of real property by 17.8 percent.

**Excluding the gas well increase,** total assessed value of real property, excluding additional assessments due to new construction or improvements to property, exceeds last year's total assessed value of real property by 5.92 percent.

2. Lowered Rate Necessary to Offset Increased Assessment: The tax rate which would levy the same amount of real estate tax as last year when multiplied by the new total assessed value of real estate with the exclusions above mentioned, would be \$0.49 per \$100 of assessed value. This rate will be known as the "lowered tax rate."

**Excluding the gas well increase,** the tax rate which would levy the same amount of real estate tax as last year when multiplied by the new total assessed value of real estate, with the other exclusions above mentioned, would be \$0.55 per \$100 of assessed value.

3. Effective Rate Increase: The County of Tazewell proposes to adopt a tax rate of \$0.58 per \$100 of assessed value. The difference between the lowered tax rate and the proposed rate would be \$.09 per \$100 or 18.37 percent. This difference will be known as the "effective tax rate increase."

**Excluding the gas well increase,** the difference between the lowered tax rate and the proposed rate would be \$0.03 per \$100 or 5.45 percent.

Individual property taxes may, however, increase at a percentage greater than or less than the above stated percentage.

4. Proposed Total Budget **Decrease**: Based on the proposed real property tax rate and changes in other revenues, the total budget of County of Tazewell will be 4.97 percent **less** than last year's budget.

The Budget reduction includes a more than \$2 million dollar decrease in State and Federal funding to Tazewell County Public Schools.

Now, the Chairman called for public comments from the floor three times and there being none, he declared the public hearing closed.

Supervisor White said he would like to set the tax rate at 0.56 per \$100.00 and recommended the Board set the rate at 0.56 due to property value increases and the large elderly population in our county. He said not reducing the tax rate to his recommendation to take the tax rate as close to the 0.55 per \$100 – revenue neutral rate would be burdensome to those folks. He requested that Supervisor Hymes and Supervisor Absher vote against the 0.57 tax rate.

Supervisor Hymes said taxes are essential for services provided by the County such as emergency services, i.e. fire, rescue, schools, law enforcement and other services. He said the Board had to be good stewards with taxpayer money.

Supervisor Stacy said the County's tax rate was one of the lowest in the state and trying to remain revenue neutral would be a waste of the \$400,000.00 tax-payer money allocated for reassessment costs. He further said reducing the tax rate further would lead to other cuts in other services, and wanted to know if the board was prepared to reduce services.

#### REAL ESTATE TAX RATE SET @ .57 per \$100.00

Then, upon motion of Supervisor Brewster, seconded by Supervisor Stacy and adopted by a vote of 3 to 2, with Supervisor White and Supervisor Hymes voting nay, the Tazewell County Board of Supervisors hereby sets the Tazewell County Real Estate Tax Levy @ .57 per \$100.00 assessed value, effective, 12:01 am, July 1, 2012.

# **TAZEWELL COUNTY BUDGET AMENDMENTS APPROVED FY2012-13**

Discussion regarding the proposed amendments to the proposed County Budget Ordinance, FY2012-13 was held. The Board approved adding back \$135,000.00 to the budget as a result of the 0.57 real estate tax levy set this date.
