## SHERIFF FRED NEWMAN – WASHINGTON COUNTY, VIRGINIA PRESENTATION OF ACCREDITATION AWARD RECEIVED BY THE TAZEWELL COUNTY SHERIFF'S OFFICE

Chairman Hymes introduced and welcomed Washington County, Virginia Sheriff, Fred Newman. Mr. Newman is a member of the Professional Standards Committee and said that Tazewell County Sheriff Brian Hieatt and his department successfully completed the recertification process for the Virginia Law Enforcement Accreditation Program and presented the certificate/honor to Sheriff Hieatt and his department which signifies a commitment to law enforcement excellence. Sheriff Brian Hieatt, along with many law enforcement officers received a round of applause from the audience and from the Board of Supervisors. Mr. Newman said the Tazewell County's Sheriff's Department is among an elite group of law enforcement agencies – with only four counties in Southwest Virginia receiving the accreditation, i.e. Washington, Wise, City of Bristol and Tazewell County. Tazewell County first accomplished this award in 2008. The award is achieved by operating the highest level of professional performance based on objective standards used to measure performance by sheriff departments in Virginia. Sheriff Hieatt said the award was a special accomplishment and takes the efforts of every member of the department to keep the accredited standings. Sheriff Hieatt said the accreditation is not a requirement, but he feels that citizens of Tazewell County deserve the greatest services from its Sheriff's Department.

#### MOUNTAIN KIDS – INCORPORATED

Greg P. Edwards, a representative from Dominion Educational Partnership, as well as representatives from Mountain Kids, Inc. attended the meeting with Mr. Edwards announcing Mountain Kids, Inc. receipt of \$3,000 to extend outdoor adventure camps at Clinch River Farms. Sara Hudson Sheets, Executive Director was present and gave a brief explanation of the hands-on camp that will use resources in Tazewell County to teach basic skills of energy. Mountain Kids, Inc. was chosen for the grant out of \$2,000,000 in requests for an eleven (11) state region with the evaluation process through a very competitive process. Members of the Board congratulated Mountain Kids, Inc. and thanked Mr. Edwards for Dominion's support and for selecting a Tazewell County organization as the recipient of the grant award.

#### **CITIZEN COMMENTS**

The chairman then called for citizen comments from the floor.

Mrs. Deborah Stockton, Grassy Spur Road, Bandy, Virginia 24602 spoke and questioned the importance of the County's application of the Crooked Road application and the designation for 19 counties. She said she was not in any way opposed to the goals of the Crooked Road in terms of music promotion or arts. She said music was a vital part of her life. But, she was concerned about the potential implications regarding land-use decisions as well as the large sum of money from the federal government that will be used as un-do influence for other county venues. Mrs. Stockton said she just wanted to know the reason for the Board's support of the Crooked Road application.

The road serves twenty three (23) homes and extends a distance of approximately four hundred (400) ft. A copy of the proposed ordinance is on file in the office of the County Administrator, 108 East Main Street, Tazewell, Virginia.

Now, the Chairman called for public comments from the floor with regard to the public hearing. The following persons commented on the proposed ordinance:

- Roy D. Cole, Bottom Road, 255 Bottom Road, Raven, VA- questioned the Boards intent of the project – just wanted to make sure the county was not going to take additional right of way.
- Thomas Woosley, 144 Woosley Street, Cedar Bluff, VA just wanted to make sure the right of way would stay the same.
- Supervisor Seth White stated that he spoke to Mr. Arrington to clarify the Boards intent with regard to paving only the existing property. He said he would make sure that the right of way is accurate with the County Administrator requested to speak with VDOT officials to evaluate the right of ways and possible drainage issues.

#### TOURISM STRATEGIC PLAN

The Tourism Strategic Plan was presented to the Board of Supervisors at a meeting held in September. Now, with those changes made as recommended, and incorporated in the Tourism Strategic Plan and upon motion of Supervisor Childress, seconded by Supervisor White and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approve the Tourism Strategic Plan as revised. The Plan as adopted will enable the County to be used as a tool to continue with tourism goals and objectives. A copy of the Tourism Strategic Plan as hereby approved is on file in the office of the County Administrator and in the office of the Economic Development Corridor.

#### VIRGINIA ENTERPRISE ZONE – ORDINANCE ADOPTED

Following a public hearing on the proposed Ordinance to Adjust the Boundaries of the Enterprise Zone for Tazewell County, and upon motion of Supervisor White, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby adopt AN ORDINANCE TO ADJUST THE BOUNDARIES OF THE ENTERPRISE ZONE FOR TAZEWELL COUNTY, VIRGINIA, as well as the MAPS as presented this date and signed by the County Administrator. The ordinance as adopted no longer remove properties in the Richlands area as previously advertised. The Enterprise Zone designation entitles the owners of properties within the zone to certain tax incentives. A copy of the ordinance in a form as hereby adopted as well as the MAPS are on file in the office of the County Administrator, 108 East Main Street, Tazewell, Virginia 24651.

#### JOINT EFFORTS WITH TOWN OF TAZEWELL, VIRGINIA
