



#### **FY14 Expenditures**




## **General Fund Comparison**

#### **General Operating Fund FY14**




## Items included in FY14 Budget

- Local required match for funding Schools in FY14 is \$10,749,851. Tazewell County BOS approved \$13,706,060 for FY14. That is 27.5% more than the state required match.
- Included \$95,000 an additional funding to School Board to complete year 2 of LPN program.
- Increased funding to EMS to begin implementation of Fire & EMS Study recommendations.
- Funding for some needed machinery & equipment, furniture & fixture, capital outlay, including upgrades to the Fairgrounds and Animal Shelter.
- Included \$120,000 for purchase of vehicles for Sheriff's office.


### Items included in FY14 Budget

- The Board approved increasing Elderly Tax Exemption income level from \$25,000 to \$30,000 annually. This will take effect January 1, 2014, allowing more citizens to qualify for the exemption for real estate tax.
- Merchants Capital Tax rate- The Board is considering lowering the rate from \$4.30 to \$3.80 for 2013.


#### **School Funding-Local Share**
