# COUNTY GARAGE UPDATE

County Administrator, Mr. Young discussed changes that will be taking place at the garage. He mentioned that they have a new strategy for the County's vehicles and that the Sheriff's Office has been instrumental in helping them come up with a fleet plan. The County will now lease vehicles from Enterprise for a period of time and then sell them and replace them with new vehicles. Previously the County would ride the vehicles until they couldn't be used anymore and then scrap them. With this change there will also be a new vehicle maintenance plan. Our fleet will now be covered by that maintenance plan which includes Sheriff's Office and Administration Office vehicles at a better deal. This means there will not be as much demand for the County Garage, so they took the assistant mechanic at the garage and transferred him into maintenance. The head mechanic, Frankie Kitts, remains and will triage county vehicles and be able to judge whether or not our garage is able to fix the problem or whether the vehicle needs to be taken somewhere else. Mr. Kitts will also oversee billing and received invoices at the garage to make sure that they come in at a fair price and work as a consultant with other garages regarding plans of these vehicles. Two days a week the County Garage will still perform certain procedures such as: oil changes, tire changes, fluid refills, etc. The former assistant mechanic may be pulled from maintenance to help perform some of these procedures. Mr. Young hopes to save money with these changes as our fleet gets younger.

Upon motion of Supervisor Hackworth, seconded by Supervisor Lester and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes and directs the County Attorney to advertise for a public hearing in November to hear concerns regarding automobile junkyard's.

# PUBLIC HEARING – PROPOSED ORDINANCE TO NAME AN UNNAMED PUBLIC STREET CONNECTING INDIAN PAINT ROAD AND THE UNITED STATES ROUTES 19 AND 460 INTERSECTION IN CLAYPOOL HILL AS ADAIR DRIVE

#### 6:45 PM

The Chairman called to order a public hearing that was duly advertised according to law regarding AN ORDINANCE TO NAME AN UNNAMED PUBLIC STREET CONNECTING INDIAN PAINT ROAD AND THE UNITED STATES ROUTES 19 AND 460 INTERSECTION AS ADAIR DRIVE.

Now, the Chairman called for public comments from the floor three times with regard to the public hearing. There being no comments he declared the public hearing closed.

The County Attorney explained that the ordinance allowing the Board to name public streets was created prior to the major 911 changes in Tazewell County circa 2000. The one street that connects Indian Paint Road and Rt. 19/460 intersection in Claypool Hill is the only unnamed street in Tazewell County that is a public thoroughfare. The Board intends to name this road Adair Drive and held this public hearing to satisfy the first step of that ordinance. The Board is also required to allow a certain time period for public comments.

Upon motion of Supervisor Lester, seconded by Supervisor Hackworth and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby end the public comment period regarding the proposed naming of Adair Drive on Tuesday, November 10, 2020.

## **CITIZEN COMMENTS - SCHEDULED**

1. Derrick Mays, Virginia Department of Criminal Justice Service – presented the Tazewell County Sheriff's Office with their fourth award for accreditation stating that they have now been accredited for twelve straight years. Mr. Mays spoke very highly of the TCSO.

Sheriff, Brian Hieatt thanked Mr. Mays for traveling all the way from Richmond to present the award in person. The Sheriff said that it was an important presentation so that the citizens of Tazewell County could see the kind of law enforcement agency that they have in the County and that it shows to them that the TCSO has went above and beyond for its citizens. TCSO is one of the very few agencies in southwest Virginia that has achieved this as an accredited agency. It was accomplished by team effort and he thanked all of the men and women that were present from the Sheriff's Office for their hard work and dedication.

Major Harold Heatley spoke saying that he was extremely proud, as the chief deputy working underneath Sheriff Hieatt's leadership, that this was the very first accreditation assessment that they have had with zero deficiencies. He thanked everyone from the TCSO.

Chairman Stacy, addressed the deputies that were present saying that the Board spends an exceptional amount of time with the Sheriff and Chief Deputy discussing deputy pay rates. Mr. Hieatt and Mr. Heatley are constantly advocating for better conditions for their employees, whether it be better equipment or fairer pay. The Chairman asked Mr. Mays if the accreditation carried any weight in the eyes of the Commonwealth that would help pay the deputies anything extra for all the work that that he has witness and required them to do to maintain their status as an accredited agency. Mr. Mays responded that he was not sure but that he did know that accredited agencies get points when it comes to filing for grants. Although he said that grants is such a sticking point that if you even sign in the wrong block you can be denied a grant. The Chairman replied with the joint effort of the Virginia Department of Criminal Justice Service, that the General Assembly has obviously demonstrated that they want to look at police reform to ensure that they have the best professionals serving the citizens of the Commonwealth of Virginia, and that it seems that Mr. Mays agency has a program that is designed to elevate every member to that level and that status, that you would think that it would not be a hard bridge to gap if

accreditation is achieved, to pay people accordingly. Chairman Stacy ended by encouraging Mr. Mays to take these considerations back to Richmond and see if anything can be done.

Supervisor Hymes stated that this was the type of job that you do it because you love it but you also have to feed your family and that the County's starting rates are lower than other's. He stated that the Board is trying to figure out what they can do to get pay levels where it needs to be so that they can maintain the professional level of the people they have and be able to replace retirees with someone highly qualified that will be able to move up the ranks. The answer is to raise base pay.

Captain Johnathon Hankins thanked Sheriff Hieatt, Major Heatley, and all TCSO employees for their hard work and devotion.

The Chair called for a brief recess and the meeting was reconvened shortly after.

## TAZEWELL COUNTY CARES UPDATE

The County Administrator discussed the CARES Round One and CARES Round Two handouts. Mr. Young pointed out that the \$316,274.58 is the funds that the Board initially gave to the COVID Public Health Committee but still have remaining. The committee used the funds to address the Bluefield College outbreak and other public health issues as they arose. These funds remaining need to be assigned.

For Round Two, the Board sent money to United Way, Clinch Valley Community Action, made down payments on three ambulances, and the Sheriff's Office placed orders on transport vehicles. They have been following up with these agencies to make sure they are spending this money. At the time of the meeting they were taking in business assistance applications for these grants. The IDA is scheduled to meet on October 14<sup>th</sup> to discuss how they want to distribute the funds that they want to give to largest employers.

Chairman Stacy asked that they consider county employees who have also suffered and worked exceptionally well and asked if they could create a category before funds go back to identify what that reserve looks like and begin to recognize that group of people who have performed valiantly through this effort. The County Administrator discussed investigating hero pay for non-medical response personnel and he believes an article from Roanoke influenced those who have inquired about the extra pay. Mr. Young stated that if one looks carefully at the articles, they reimbursed themselves from CARES funds and then payed their people a bonus from their own coffer. He recommended that when our county gets close to the end of the year that they reimburse itself for as many costs as it can, further recommending that they put in a line item called COVID, which would give the County more money the next calendar year to do things like that with it.

For Round One, the CARES Public Health Committee approved \$15,000.00 to pay testing fees for public employees. Testing machines and testing supplies were purchased with CARES funds for Clinch Valley Medical Center, Bluefield College, and Appalachian Agency for Senior Citizens (which hadn't arrived yet). To process the test CVMC have been charging our people a fee of \$57.00 a person as a labor cost. Mr. Young stated he did not have a problem with this but it was brought to his attention when they were having the issue with Bluefield area schools that they had many teachers needing to be tested before they could come back to work and they were sent to Bluefield College. They were not charging those getting tested but there were only so many people they could test and when they were hit with an outbreak they were swamped, causing people to leave and go to Clinch Valley Medical Center which charged them the fee. He explained that our insurance pays 100% for the employee but our insurance is selffunded which means in the end the County still pays for it. The County Administrator requested the Board to set aside \$15,000.00 to help with this issue. They have made agreements with these facilities that when an employee shows up with their ID and that their potential exposure was through our workplace then the County pays for it with the \$15,000.00 set aside and that they will bill us directly.

Supervisor Hymes recommended that they set aside \$30,000.00 instead and see how it goes. Mr. Young thought this was a good idea and said that he would like to have 75% of the funds going to the school system and 25% of it to us because they have more employees and profound interests.

Upon motion of Supervisor Hymes, seconded by Supervisor Hackworth and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes the amount of \$30,000.00 out of \$316,274.58 committed to pay test processing fees for County employees and upon further

motion authorizes the amount of \$20,000.00 to go towards school system employees and the remainder amount of \$10,000.00 for county employees.

#### **BROADBAND PROJECTS**

#### **CARES FUNDS ROUND TWO**

# AUTHORIZED TO MOVE \$25,000.00 FROM BROADBAND FUNDS PREVIOUSLY SET ASIDE FOR POINT BROADBAND AND SPECTRUM TO THE BROADBAND PROJECT WITH COMCAST FOR ROSENBAUM ROAD

Mr. Young discussed CARES Round Two. There is \$650,000.00 for broadband funding with \$50,000.00 set aside for mobile hotspots. The Point Broadband Agreement ended up coming in far less than anticipated so there is some room leftover in this amount. He commented he would still like to see if Spectrum is able to do anything. Mr. Young requested to move these monies around. He has a letter from Comcast stating that they can serve half of the homes on Rosenbaum Road for \$11,000.00 and would provide the County another letter when they figure out what the other half would be.

Upon motion of Supervisor Asbury, seconded by Supervisor Hackworth and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorize moving \$25,000.00 from the broadband funds previously set aside for Point Broadband and Spectrum to the broadband project with Comcast on Rosenbaum Road. A copy of the letter from Comcast is on file in the County Administration building, 197 Main Street, Tazewell, Virginia 24651.

#### TREASUER'S OFFICE

# AUTHORIZED \$500.00 TRANSFER FROM ROUND ONE CARES FUNDS TO PHASE II PUBLIC HEALTH FUNDS - TREASURER'S OFFICE DROP BOXES

Upon motion of Supervisor Lester, seconded by Supervisor Hackworth and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorize a transfer in the amount of \$500.00 from CARES Round One funds to Phase II Public Health funds to pay for two drop boxes to limit public exposures due to COVID.

### REPURPOSING FUNDS PREVIOUSLY INTENDED FOR COURTHOUSE FACE SHIELDS

#### **REPURPOSED \$10,000.00 FROM CARES ROUND ONE – THERMAL DETECTORS**

Previously the Board approved up to \$20,000.00 for face shields for the courthouse in round one as part of the \$404,000.00 request made by emergency management. Prices of these

face shields are fluctuating and are now half the cost of what they were. Cheaper ones were found and are now only expected to cost approximately \$8,000.00.

The Sheriff's Office requested thermal detectors to be placed at courthouse and sheriff's office entrances. Currently officers are checking temperatures when citizens come in. Thermal detecting devices cost \$2,000.00 apiece and if someone is over a certain temperature when they walk through the device will ding you.

Upon motion of Supervisor Hackworth, seconded by Supervisor Asbury and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby repurpose the funds previously approved for face shields at the courthouse; \$10,000.00 to be used for purchasing thermal detectors for entrances of the courthouse, sheriff's office, and magistrate's office at the regional jail.

## CVCA UTILITY AND RENT ASSISTANCE

The County Administrator discussed that they were having difficulties pushing out this money. Previously the Board approved \$40,000.00 to CVCA for utility assistance for people who lost their jobs during the pandemic. He requested that the Board expand that to utility and rent assistance because not a lot of people are calling for that help.

Upon motion of Supervisor Hackworth, seconded by Supervisor Asbury and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby expand purposes of which the CVCA grant can be used to include rent payments for persons who lost their jobs during the COVID-19 crisis.

# TAZEWELL FOUR SEASONS YMCA

As part of the human services assistance the Board, previously in Phase II, gave \$5,000.00 to Four Seasons YMCA in Tazewell, to buy a UV bulb to go into their pool. The YMCA discovered while trying to service the fixture in the pool that it was in poor shape and hadn't been used and was going to cost them \$3,000.00 to fix it. They requested to repurpose the funds given to them by the Board and use them towards water bottle refilling stations and a fumigation team. Mr. Young then asked that any remaining funds be used for PPE.

Upon motion of Supervisor Hymes, seconded by Supervisor Asbury and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approve Tazewell Four Seasons YMCA's request to repurpose their funds previously intended to purchase a UV bulb for their pool to now go towards water bottle refilling stations and a fumigation team with any remaining funds to be used for PPE.

#### FOOD PANTRY UPDATE

The Board at a previous meeting approved monies to go to A Child Shall Lead Them food pantry. Mrs. Matney contacted them and they reported that they closed in March for some time and have recently reopened but are only open two days a week. She asked them if they needed any assistance and the food pantry felt like they were okay for now.

## **RUSSELL STOWERS - CLEARFORK FIRE DEPARTMENT REQUEST**

Fire Chief, Russell Stowers approached the Board asking them to consider using CARES Act funding to purchase a pickup truck for the Clearfork Volunteer Fire Department. Mr. Stowers stated that the truck would be used to respond and assist with EMS calls and help with the decontamination of their fire personnel as well as other first responders. He said that the department already has purchased its own PPE but that the truck would be able to enhance their capabilities by transporting more members for EMS assistance as well as carrying the equipment needed for responding to emergencies that may involve someone that has Covid-19. He requested \$45,000.00.

The Board decided to send Mr. Stowers request to the CARES Act committee.

## **RESCINDED TRAILBLAZER'S COMMITTEE APPOINTMENT**

The County Attorney revisited the motion made earlier to appoint Curt Breeding to the Trailblazer's Committee. Mr. Collins explained that procedurally they would first need to remove the current representative Cody Cordle from the committee. The Board had questions whether Mr. Cordle had moved or resigned.

Upon motion of Supervisor Hackworth, seconded by Supervisor Hymes and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby rescind their motion made earlier in the meeting appointing Curt Breeding to the Trailblazers Board.
