PUBLIC HEARING

\$43,000.00 FROM CARES ACT FUNDING

The Chairman called to order a public hearing that was duly advertised according to law regarding, "PROPOSED ORDINANCE TO APPROVE A BONUS FOR CERTAIN EMPLOYEES OF TAZEWELL COUNTY SHERIFF'S OFFICE, TAZEWELL COUNTY EMERGENCY MANAGEMENT, TAZEWELL COUNTY MAINTENANCE, AND TAZEWELL COUNTY ADMINISTRATION."

Proposed Ordinance to Approve a Bonus for Certain Employees of Tazewell County Sheriff's Office, Tazewell County Emergency Management, Tazewell County Maintenance, and Tazewell County Administration

No one rose to comment nor spoke via telephone. The chairman called three times and there being no more speakers, he closed the meeting.

Upon motion of Supervisor Stacy, seconded by Supervisor Plaster and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the amount of \$42,000.00 from CARES Act funds, for a onetime bonus of \$3,000.00 for fourteen (14) Tazewell County Sheriff's Office Employees, \$2,000.00 for six (6) Tazewell County Emergency Management employees, \$1,000.00 for nine (9) Tazewell County Maintenance Employees, and \$500.00 for three (3) Tazewell County Administration employees. A copy of the Ordinance is on file in the County Administrator's Office, 197 Main Street, Tazewell, VA 24651.

SPECIAL PRESENTATIONS

Supervisor Asbury welcomed the West Virginia Lady Red Devils and presented a resolution commending them on their achievements.

Upon motion of Supervisor Asbury, seconded by Supervisor Stacy and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby adopts, "A RESOLUTION TO HONOR AND CONGRATULATE THE WEST VIRGINIA LADY RED DEVILS". A copy of the Resolution is on file in the County Administrator's Office, 197 Main Street, Tazewell, Virginia 24651.

REDISTRICTING COMMITTEE REPORT

County Administrator, Eric Young, presented a map of the proposed redistricting changes. He stated how Tazewell County received the Census six months late. He stated that the Redistricting Committee recommended Tazewell County keep the current five districts. Mr. Young stated that Tazewell County has about 40,429 residents. Divided between the five districts, this is roughly 8,086. Mr. Young stated the committee wanted to make minimal changes to not disrupt the voters. The committee decided to move the boundary between the Southern district and the Eastern district to the western end of Industry Road. Mr. Young stated that the committee also decided to move the boundary on Wardell Road to add more voters to the Western District. Other changes to make it more convenient to voters were on RT. 61- Nye Valley Road, small area of the Tip Top community, County Farm Road, and Bearwallow Road.

Upon motion of Supervisor Plaster, seconded by Supervisor Stacy and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the administrator to advertise for a Redistricting Hearing for proposed changes.

Upon motion of Supervisor Stacy, seconded by Supervisor Asbury and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the County Attorney to seek a certification of no objection letter from the Attorney General's office.

COVID UPDATE

County Administrator, Eric Young, stated that in November the Health Department gave Tazewell County a negative eighteen number. He stated that COVID numbers have not dropped and remain relatively steady. He stated Tazewell County is averaging 10 COVID cases a day. Mr. Young stated that he anticipates that there will be a spike in numbers after the Holiday season. He state the local hospitals are in good shape.

ARPA FUNDING

WORKFORCE PRESENTATION

\$200,000.00 FROM ARPA FUNDING

Tiffany Goff presented a small presentation of Workforce's CARS to Work Program and their Youth Program. She asked the board if they had any questions from the previous board meeting. She went over how participants must live in the county, have insurance, have a valid Virginia Driver's license, and fall within the income guidelines. She stated that most families in Tazewell County would qualify for these programs. Miss Goff requested funding for these programs. The funding asked for would be \$100,000.00 for the CARS program and \$100,000.00 for the youth program. These funds could come from ARPA funding. The board discussed the matter. Supervisor Stacy expressed reservations about the plan.

Upon motion of Supervisor Plaster, seconded by Supervisor Asbury and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes \$200,000.00 from the ARPA funds for the Workforce CARS program and Youth Program.

Mr. Young suggested that the funding for these programs will come from the allocated \$90,000.00 of the FY22 childcare section and \$110,000.00 from the FY22 Business Recovery Section of ARPA funding.

Upon motion of Supervisor Plaster, seconded by Supervisor Stacy and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes \$90,000.00 from the FY22 Childcare Section and \$110,000.00 from the FY22 Business Recovery Section of ARPA funding to be used to fund the Workforce CARS and Youth Programs.

CEDAR BLUFF ELEMENTARY

\$21,000.00 FROM ARPA FUNDING

Buffie Crabtree, Principal of Cedar Bluff Elementary, had requested and the board had approved funds of \$21,000.00 to Tazewell County Public Schools for replacement of older playground equipment.

Mr. Lester suggested funding the request from ARPA funds. The county Attorney and County Administrator expressed concerns that ARPA funds could not be used for such purpose.

Upon motion of Supervisor Lester, seconded by Supervisor Plaster and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the amount of \$21,000.00 from ARPA funds, for funding new playground equipment for Cedar Bluff Elementary School, to be added to the consent calendar for December, contingent on legal review.

MOBILE GENERATOR

\$1,200 FROM ARPA FUNDING

County Administrator, Eric Young, explained that, as he had mentioned at the last meeting, the county needs a backup generator for mobile field hospital/vaccination clinics. He stated that now, however, the time line for delivery doesn't match up to the need. Mr. Young stated that Mr. White can purchase a power adapter pigtail so a mobile unit can be deployed.

He recommended that the \$1,200.00 funding for the generator/adapter would come from the allocated Public Health Section of ARPA Funding.

Upon motion of Supervisor Stacy, seconded by Supervisor Asbury and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the amount of \$1,200.00 from the FY22 Public Health Section of ARPA funds, for funding the generator power adapter pigtail needed for the mobile field hospital/vaccination clinics.

CONSIDERATION OF GRANTS FOR LARGER EMPLOYERS

\$100,000.00 FROM ARPA FUNDING

County Administrator, Eric Young, opened up discussion about a consideration for grants to help larger employers of Tazewell County, companies with over 100 employees. Mr. Young stated that these larger companies will soon be hit with new COVID mandates for testing weekly. He stated that this will be a big hit financially to these larger companies. Supervisor Lester discussed how these larger employers have continued to be hit by the impact of COVID and have continued to keep the doors open. Supervisor Lester agreed with Mr. Young that the larger companies would need these grants to help with the new testing mandates. Supervisor Stacy expressed he had some reservations about giving grants to larger companies opposed to smaller businesses. Mr. Young requested \$200,000.00 for this purpose.

Upon motion of Supervisor Lester, seconded by Supervisor Plaster and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the amount of \$100,000.00, \$25,000.00 per non-retail large employer, from the FY24 (third year) Business Recovery Section of ARPA funds for grants to the four non-retail larger employees in Tazewell County, who employ more than 100 persons.

STIPEND REQUEST FOR PSA

County Administrator, Mr. Young stated that he received a request from Mr. Ball of the PSA, that the PSA employees get the same stipend that other public service employees in the county had received. No motion was made.

PAYMENT FOR PROJECT JONAH TO THE PSA

\$404,000.00 FROM ARPA FUNDING

Mr. Young explained that the previously designated ARPA funds for the Jonah water project could be used for that purpose but would not count toward a federal grant match for the project, if designated as infrastructure funds. He suggested making the contribution through a different route.

Upon motion of Supervisor Plaster, seconded by Supervisor Stacy and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the amount of \$500,000.00, be transferred from the FY22 PSA Infrastructure section of ARPA funding to the FY22 Revenue Recovery section.

Upon motion of Supervisor Plaster, seconded by Supervisor Stacy and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the amount of \$500,000.00, be transferred from the FY22 Revenue Recovery section of ARPA funding to the boards General Fund and added to Capital Contingency Section of the boards FY22 Budget.

Upon motion of Supervisor Plaster, seconded by Supervisor Asbury and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the amount of \$404,000.00, from its Capital Contingency for payment to the Tazewell County PSA for water and waste water projects for Project Jonah.

FUNDING FOR COURT ROOM UPDATES

\$15,000.00 FROM ARPA FUNDING

Upon motion of Supervisor Stacy, seconded by Supervisor Plaster and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the amount of up to \$15,000.00, from the FY23 IT Infrastructure Upgrade Section of ARPA funds for funding for the updated cameras and other "hands free" equipment for the Tazewell County Court Rooms.

CARES FUNDING

EMS REIMBURSEMENT PAY

Mr. Young stated that due to the sharp increase in COVID-19 cases in the fall, the county EMT's were sufficiently dedicated to fighting COVID such that reimbursing their pay from ARPA would be acceptable.

PURCHASE OF FIRE APPRATUS

\$10,000.00 FROM EMS CONTINGENCY \$40,000.00 FROM FIRE APPARATUS

Mr. Young and Mr. Brooks both recommended donating funds to Tannersville Volunteer Fire Department for a \$50,000.00 fire apparatus. Mr. Young stated the county had budgeted \$40,000.00 for this purpose. Mr. Brooks agreed to take \$10,000.00 from the EMS Contingency. The Tannersville Volunteer Fire Department will purchase the fire apparatus then donate that back to Tazewell County so the county can put the apparatus on their insurance.

Upon motion of Supervisor Stacy, seconded by Supervisor Plaster and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the transfer of \$10,000.00 from the EMS Contingency Account (Acct# 4-100-32040-7023) to the Fire Apparatus Account (Acct# 4-100-32010-8105) and to donate \$50,000.00 to the Tannersville Volunteer Fire Department from the Fire Apparatus Account for purchase of Fire Apparatus.

WORC GRANT UPDATE

County Administrator, Eric Young, explained the WORC grant was for the advanced welding center for the Tazewell County Vocational Center. This funding was for robotic equipment. Mr. Young stated the county got approval to buy the equipment. He also stated the equipment should arrive by February 2022. The first set of students should enter the program in March 2022. Mr. Young stated this program is for students and adults.

CAVITT'S CREEK TRAIL GRANT UPDATE

Mr. Young stated that the county was awarded a grant of \$150,000.00 from the state and \$100,000.00 from Cumberland Plateau for the Cavitt's Creek Trail. He stated the county is trying

to procure someone to do an environmental assessment of the trail. Mr. Young also stated that there needs to be an assessment of the diversity of the communities that will be benefited from the trail. He stated that hopefully by spring the county will be able to get started.

JUNK VEHICLES AT LANDFILL

County Administrator, Eric Young, stated that the landfill has multiple junk vehicles. He stated that he wants to procure a company that will take the vehicles off and sell the metal from these vehicles by the pound.

Upon motion of Supervisor Stacy, seconded by Supervisor Asbury and adopted by a vote of 4 to 0, with Supervisor Hymes absent, the Tazewell County Board of Supervisors hereby authorizes the County Administrator to accept the highest bid for the sale of junk vehicles for scrap metal at the landfill.

TRANSIENT OCCUPANCY TAX

County Attorney, Chase Collins, stated the treasurer wanted to update the new transient occupancy tax ordinance to reflect the recent changes made by Virginia's General Assembly. He is requesting a public hearing be made for the December board meeting.
