# ACTION FOLLOWING EXECUTIVE SESSION

#### SOUTHWEST REGIONAL JAIL AUTHORITY

Mr. Collins asked that the Board consider approving the resolution approving the amendments to the regional jail agreement with the Southwest Regional Jail Authority, including the Resolution and Agreement Amendments as presented, and authorize the Chairman and the County Administrator to execute those documents and any other such documents as may be necessary to approve such amendment, subject to legal review.

Upon motion of Supervisor Stacy, seconded by Supervisor Hroatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approve the amendments to the regional jail agreement with the Southwest Regional Jail Authority, including the Resolution and Agreement Amendment as presented and authorize the Chairman and County Administrator to execute those documents and any other such documents as may be necessary to approve such amendment, subject to legal review. # **SPECIAL PRESENTATION**

# REDISTRICTING REVISIONS

County Administrator, Eric Young, stated that the state of Virginia has removed the inmates from the Northern District. He stated the Redistricting Committee needs to make some more changes due to this. Mr. Young stated that each district needs to have within 5% above or below 7,998 residents. He stated that the Northern District needed to add 186 residents to be within this 5%. Mr. Young then stated that the Southern District needed to reduce its area by 146 residents. Mr. Young recommended to the board to move the 6 residents of Clearfork Road to the Southern District from the Eastern District. He also recommended to the board to for the 104 residents on Industry Road in the Southern District be moved to the Northern District. He also recommended to the board that the 77 residents in the unincorporated area in the Southern District be moved to the Northern District. Mr. Young then acknowledged the previous changes brought in front of the board at the December meeting.

Supervisor Stacy asked Mr. Young if there was any other practical reason for the redistricting other than where the resident votes at. Supervisor Gillespie stated that the registrar's office will also have to deal with all of these changes to districts. Supervisor Gillespie also asked if the board is locked in on these decisions or if they can amend these redistricting choices. County Attorney, Chase Collins, stated that there will be a second public hearing for responses, and to amend any redistricting choices.

# **PUBLIC HEARINGS**

#### **EVA'S WALK**

The Chairman called to order a public hearing that was duly advertised according to law regarding, "AN ORDINANCE TO ACCEPT EVA'S WALK INTO THE TAZEWELL

# COUNTY ROAD SYSTEM PURSUANT TO SECTION 15.2-2006 OF THE CODE OF VIRGINIA (1950).

Proposed ordinance to add Eva's Walk into Tazewell County's Road System.

County Attorney, Chase Collins, stated that Eva's Walk is owned by equal parts in a HOA. He stated that this road had many drainage problems. Mr. Collins said this ordinance has come before the Planning Commission. He stated that the Planning Commission recommended adopting this ordinance.

Mike Lutrell, a resident of Eva's Walk, stated that the HOA had been working for well over a year to correct the drainage issues. He stated the HOA brought in a contractor to resolve these issues. He asked the board if they had any questions about the Eva's Walk HOA. Supervisor Stacy inquired as to the location of Eva's Walk.

Upon motion of Supervisor Stacy, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves the ordinance to add Eva's Walk to the Tazewell County Road System in accordance with Section 58.1-3819. A copy of the ordinance is on file in the County Administrator's office.

### REDISTRICTING

The Chairman called to order a public hearing that was duly advertised according to law regarding, "AN ORDINANCE TO AMEND AN ORDINANCE TO PROVIDE FOR THE REDISTRICTING OF THE BOUNDARY LINES OF THE BOARD OF SUPERVISORS ELECTION DISTRICTS AND PRECINCTS AND TO RELOCATE CERTAIN POLLING PLACES WITHIN TAZEWELL COUNTY, VIRGINIA, TO BE EFFECTIVE APRIL 1,2022, PURSUANT TO SECTIONS 15.2-1211, 15.2-1425, 24.2-129 AND 24.2-304.1 ET SEQ OF THE CODE OF VIRGINIA (1950).

Proposed ordinance to amend an ordinance to redistrict the Board of Supervisors election districts, precincts and to relocate certain polling places.

The Board expressed concern about the lack of public interest or concerns of the proposal. Mr. Young gave a lengthy presentation regarding changes staff recommended to the Committee's proposal based on the state's decision to exclude inmates at the Pocahontas Correctional Facility from the Northern District counts.

County Attorney, Chase Collins, requested the board move to let him, Mr. Dunford, and Mr. Young get the metes and bounds description and produce the maps of the changes under this ordinance, secondly, advertise the public comment period from January 11, 2022 to the March 2022 meeting.

Upon motion of Supervisor Stacy, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same,

the Tazewell County Board of Supervisors hereby approves the County Attorney, County Engineer, and County Administrator to get the metes and bounds description and produce the maps of the changes in this ordinance.

Upon motion of Supervisor Hrovatic, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approves the endorsement of the public comment period running from January 11, 2022 to the March 2022 meeting.

# **KENNETH DUNFORD – DIRECTOR OF ENGINEERING**

### LANDFILL ENTERPRISE

Mr. Dunford explained that he received a letter from the Town of Lebanon requesting that sludge from the Town Water Treatment Plant be taken in at the Landfill. He recommends they provide a yearly analysis and their fee would be set at \$33.00 a ton.

Upon motion of Supervisor Hrovatic, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes the Landfill to take in the sludge from the Town of Lebanon and to charge the associated fee of \$33.00 per ton.

# \$71,614.40 from Account# 42050-3270 Landfill Water Monitoring

Mr. Dunford explained that he had received the 2<sup>nd</sup> year renewal for Groundwater Monitoring for the Landfill from Marshall Miller & Associates. There has been an increase due to the cost of lab work and the cost will be \$71,614.50.

Upon motion of Supervisor Stacy, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes the amount of \$71,614.50 from the Landfill Water Monitoring account for Ground Water Monitoring at the Landfill.

# \$1,920.00 from Account# 42050-3270 Landfill Gas Monitoring

Mr. Dunford explained he received the renewal for Gas Monitoring at the land fill and the cost will be \$1,920.00.

Upon motion of Supervisor Stacy, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes the amount of \$1,920.00 from the Landfill Water Monitoring account for Ground Water Monitoring at the Landfill.

# **CAVITTS CREEK TRAILS**

Mr. Dunford stated how the county has gotten grants for the Cavitts Creek trails. He stated to receive these grants the county must do environmental assessments. Mr. Dunford stated that he but out to receive proposals for this work. He stated he received one proposal to do this work and it was for \$41,250.00. Mr. Young pointed out that the \$150,000.00 grant from the state required the \$41,000.00 study.

Upon motion of Supervisor Stacy, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes the amount of \$41,250.00 for the contract for Environmental Assessments for Cayvitts Creak Trails.

# **COVID UPDATE**

# **CASE NUMBER UPDATE**

County Administrator, Eric Young, stated that the county has had a rise in COVID numbers since the Thanksgiving holiday. He stated that we are in a spike of numbers currently due to the Christmas holiday. Mr. Young stated that the local emergency rooms are full and running out of places to send patients. He stated that the current average of positive Covid tests is 50 people a day. Mr. Young stated that the county should see another spike in numbers at the end of January 2022.

Supervisor Stacy asked Mr. Young if the county had any current open testing sites. He asked if the county had any advertisements were out stating not to use the emergency rooms to get Covid tested. Mr. Young stated the county may do a press release to state "don't use the emergency rooms for Covid testing."

# CARES ACT FUNDING / AMERICAN RESCUE PLAN ACT FUNDING

# **CARES FUNDING**

County Administrator, Eric Young, stated that the counties had received two rounds of CARES money. One round in June for \$3.5 Million and the second round in August for \$3.5 Million. He stated that the county spent \$7,083,514.00 of this CARES funding.

Mr. Young stated that the counties DSS/CSA foster care funding ran over budget by \$600,000.00. He stated that this was because more children are in foster care. He stated that the board had approved using CARES funding to cover this overrun. Mr. Young then stated how the state of Virginia pays 75% of the funding for foster care and the DSS pays 25% of the funding. He stated that the state of Virginia used their CARES funds for their share of the overrun so therefore the DSS couldn't use CARES funds to match this and pay their portion. He stated that the county will have to return \$141,000.00 of CARES money.

Mr. Young stated the county gave Clinch Valley Community Action \$40,000.00 of CARES funds to help county residents pay their utility bills. He stated they didn't spend \$12,426.00 of this money. Mr. Young stated that this money will have to be returned.

Mr. Young stated that the county gave Clinch Valley Medical Center \$549,612.50 of CARES funding. Clinch Valley Medical Center used all of this money except \$1,350.00. This amount will need to be returned.

Mr. Young stated that on December 15, 2021 the Treasury put out and advisement on what "spent" means. Spent means if you have a contractual agreement, this is considered spent.

Upon motion of Supervisor Stacy, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes the County Administrator to refund \$154,776.77 of CARES funding.

# **APRA**

County Administrator, Eric Young, discussed the ARPA Budget. He stated that the county took the ARPA funding and divided it into three different years. He stated that county had budgeted to spend money on certain items that are no longer allowed. Mr. Young stated that these funds will need to be reallocated.

# \$20,000.00 from Capital Contingency Funds

The Courthouse Grounds Improvement Committee Made a presentation to the Board regarding their recommendation to improve the ground by adding murals on the wall of a building facing the veterans' memorial to recognize the County's African-American Heritage. After hearing the presentation and discussing the size and shape of the mural, each member of the committee present spoke regarding the contributions made by a specific persons whose appearance would be represented on the mural. The Board discussed the issue and reviewed sample art from Ellen Elmes, who had worked with the Committee. Ms. Elmes presented a proposed budget for the artwork which would cost approximately \$16,500.00.

Upon motion of Supervisor Stacy, seconded by Supervisor Asbury and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes up to \$20,000.00 from Capital Cont to

help facilitate the Mural & Narrative History Project Honoring Tazewell County's African American Heritage.
