## Amonate Precinct

Beginning at a point where Route 637 Dry Fork Rd intersects McDowell - Tazewell County line and the West Virginia – Virginia boundary line; thence northeast along the McDowell - Tazewell County line and the West Virginia – Virginia boundary line to a point where census blocks 3009 and 3008 intersect just past the Bishop Prep Plant Slurry Impoundment; thence following the eastern boundary of census block 3009 southerly to a point intersecting Route 641 Grassy Spur Rd; thence continuing southeasterly along the eastern boundary of census block 3015 to a point intersecting an unnamed road just north of Route 643 Johnsons Branch Rd; thence following the unnamed road west then south to intersection with Route 643 Johnsons Branch Rd; thence following Route 643 Johnsons Branch Rd southwesterly to a point in curve where an unidentified census block line intersects at the southeast corner of census block 3021; thence following the southern then western boundary of census block 3021 to Route 676 Back Hollow Rd and Beavers Rd intersect; thence west along Route 676 Back Hollow Rd to intersection with Route 637 Dry Fork Rd; thence north on Route 637 180 feet to intersection with an unidentified census block line at the southeast corner of census block 3000; thence following the southern then western boundary of census block 3000 westerly to its intersection with Route 624 Amonate Rd; thence continuing north along the eastern boundary of census block 4038 to the McDowell - Tazewell County line and the West Virginia – Virginia boundary line; thence easterly along the McDowell - Tazewell County line and the West Virginia – Virginia boundary line to the point of Beginning.

## Bandy Precinct

Beginning at the intersection of Route 616, Route 622 and the Buchanan – Tazewell County line, thence northeasterly along the Buchanan – Tazewell County line approximately 4.3 miles to a point where census blocks 4003 and 4001 intersect at an unidentified census block line; thence southwesterly along the along the boundary between census blocks 4003 and 4001 to the intersection with Treetop Rd; thence southerly along Treetop Rd and continuing with an unnamed road, also being the western boundary of census block 4001 to the intersection with a stream named North Fork; thence southerly along North Fork to intersection with Indian Creek just below Route 628; thence southerly with Indian Creek 0.44 miles to intersection with an unnamed road; thence following the unnamed road southerly, also being the boundary between census blocks 4011 and 4010, to intersection with an unnamed stream; thence with the unnamed stream south to intersection with Route 612, Greasey Creek Rd; thence south with Route 612, Greasey Creek Rd 0.3 miles to intersection with an unidentified census block edge where census blocks 4013 and 4055 intersect; thence following the southern and western boundary of census block 4013 in a southern then western then northern direction to the intersection with Route 624, Panther Branch Rd at the top of a ridge where census blocks 4036, 4013, and 4034 intersect; thence following the boundary between census blocks 4034 and 4036 890 feet west to the intersection with Laurel Fork; thence following Laurel Fork downstream in a southerly direction to a point where census blocks 4043, 4052, and 4048 intersect; thence following an unnamed road southeasterly along the southern boundary of census block 4052 to a point intersecting Route 626 Ravens Nest Branch Rd; thence following Route 626 south to intersection with Route 630 Laurel Rd; thence southeasterly with Route 630 to intersection with Laurel Fork; thence following Laurel Fork southeasterly to intersection with Route 627 Bandy Rd; thence following Route 627 southeasterly to its intersection with Route 636 McGuire Valley Rd; thence following Route 636 easterly to intersection with Route 636 Lick Branch Rd; thence following Route 636 Lick Branch Rd easterly to intersection with Route 639 Cliff Rd also being the southeast corner of census block 3015; thence following the eastern boundary of census blocks 3015 and 3014 to intersection with Route 626 Sinking Waters Rd; thence continuing north following the eastern boundary of census blocks 3006 to intersection with Route 624 Amonate Rd; thence continuing north along census block 4038 to the West Virginia – Virginia State Line; thence northwest along West Virginia – Virginia State Line to the point of intersection of Tazewell County Virginia-McDowell County West Virginia-Buchanan County Virginia; thence following the Tazewell County-Buchanan County line southwesterly to the point of Beginning.

## Baptist Valley

Beginning at the intersection of Route 631 Baptist Valley Rd and Route 699 Green Mountain Rd; thence proceeding southwest along Route 699 to its intersection with Route 637 Limestone Rd; thence easterly along Route 637, Limestone Rd to its intersection with the Clinch River; thence following the Clinch River easterly to its intersection with Route 637, Cochran Hollow Rd; thence following Route 637 north to the intersection with Route 631, Baptist Valley Rd; thence following Route 631 southwesterly the intersection with Route 639, Cliff Rd; thence northeasterly with Route 639 Cliff Rd to intersection with Route 636 Lick Branch Rd; thence southwest on Route 636 Lick Branch Rd to intersection with Route 636 McGuire Valley Rd; thence following Route 636 McGuire Valley Rd to intersection with Route 631, Baptist Valley Rd; thence southeasterly along Route 631 to the point of Beginning.

## Bishop Precinct

Beginning at a point where the Route 644, Abbs Valley Rd intersects the West Virginia – Virginia State Line; thence northeast with the West Virginia – Virginia State Line to a point on Big Stone Ridge where census blocks 1012 and 1001 intersect at an unidentified census block line; thence following the eastern boundary of the following census blocks in a southeastern direction: 1012, 1011, 1010 (intersecting Route 644, 1008 and 1014 to a point intersecting Route 643, Mud Fork Rd; thence following Route 643 westerly to its intersection with Route 651, T R Barrett Rd; thence south on Route 651 to a point intersecting an unnamed road just past the curves also being the southeast corner of census block 1027; thence following the unnamed road and the southern boundary of census blocks 1027 to intersection with Cavitts Creek; thence following Cavitts Creek southwesterly 0.6 miles to a point at the terminus of Mountain Lake Dr; thence following Mountain Lake Dr southwesterly to its intersection with Route 643 Healing Springs Rd; thence following Route 643 northwesterly to its intersection with Mud Fork Rd (also Route 643); thence continuing with Route 643 Mud Fork Rd westerly to its intersection with Route 16 Stoney Ridge Rd; thence following Route 16 southwesterly to its intersection with Route 643 Johnsons Branch Rd; thence following Route 643 Johnsons Branch Rd southwesterly to its intersection with an American Electric Power line; thence following northwest along the American Electric Power line 0.71 miles to a point with an unidentified census block line where census blocks 3004, 3017, and 3015 intersect; thence following the eastern boundary of census block 3015 northwest to intersection with Route 641 Grassy Spur Rd; thence continuing north along the eastern boundary of census block 3009 to the West Virginia – Virginia State Line; thence following the West Virginia – Virginia State Line to the point of Beginning.

## Burkes Garden Precinct

Beginning at a point on Rich Mountain due south of the Concord Methodist Church, thence proceeding easterly with the top of Rich Mountain about 1/8 (one-eighth) mile west of Crabtree on the Bland-Tazewell County Line; thence proceeding southerly and westerly with the Bland-Tazewell County Line along the top of Garden Mountain to a point where Chestnut Ridge intersects Garden Mountain near the Chestnut Ridge Fire Tower; thence proceeding northerly with the meanders of Garden Mountain to a point where it intersects with Clinch Mountain which is also a point on the Tennessee Valley Drainage Divide; thence following the Tennessee Valley Drainage Divide around the ridge to a point 0.25 miles due south of the point of beginning; thence due north 0.25 miles to the point of beginning

## Cedar Bluff Precinct

Beginning at a point where Little River intersects with the Russell – Tazewell County line; thence following the Little River easterly to intersection with Route 19, Steelsburg Hwy; thence following Route 19 northeasterly to intersection with Route 637, Limestone Rd; thence following Route 637 northeasterly to intersection with Route 699, Green Mountain Rd; thence following Route 699 northerly to intersection with Route 631, Baptist Valley Rd; thence following Route 631 northwest to intersection with Route 627, Bandy Rd; thence following Route 627 northwest past Buck Hollow Rd to intersection with Laurel Fork; thence following Laurel Fork northwesterly to intersection with Route 630; thence following Route 630 northwesterly to intersection with Route 626; thence following Route 626 north to a point where census blocks 3028, 4051, and 4048 intersect (just west of Sumpter Rd); thence following an unnamed drive being the boundary of 4048 in a north and northwesterly direction 0.18 miles to a point where census blocks 4048, 4052 and 4043 intersect; thence following the northern boundary of census block 4048 southwesterly to the intersection with Middle Creek Rd and Stinson Ridge Rd; thence following Middle Creek Rd 50 feet to a point where census blocks 4056 and 4048 intersect; thence following the western edge of census blocks 4048, 3005, 3004, 3010, and 3013 southwesterly 1.32 miles to the intersection with Richlands Corporate limits just north of Richlands Highschool; thence following the Richlands Corporate limits southeasterly to a point where it meets the Cedar Bluff Corporate limits; thence following the Richlands-Cedar Bluff Corporate limits to the south to a point where the limits separate; thence following the Richlands Corporate limits southwesterly to a point of intersection with Randal Rd; thence following Randal Rd 0.26 miles to intersection with an unnamed stream; thence following unnamed stream northwest 268 feet to intersection with another unnamed stream; thence following the unnamed stream southwesterly 1,570 feet to intersection with an unnamed drive at 610 Country Farms Rd; thence following unnamed drive northwest 870 feet to intersection with Country Farms Rd; thence following Country Farms Rd west to intersection with Rehobeth Rd; thence following Rehobeth Rd south for 20 feet to unnamed stream; thence following the unnamed stream southerly to an intersection with an unnamed road; thence following said unnamed road westerly to its intersection with Pepper Loop St; thence following Pepper Loop St southeast then west to its intersection with Route 609; thence along route 609 northerly to its intersection with the Richlands Corporate limits; thence following the Richlands Corporate limits westerly to its intersection with Route 629; thence proceeding westerly along Route 629 to its intersection with the Russell-Tazewell County line; thence following Russell-Tazewell County line south to the point of beginning.

## Clear Fork Precinct

Beginning at a point on the Bland and Tazewell County Line where Cove Creek Rd intersects county line; thence proceeding with the Bland and Smyth County Line south and then west to a point 0.3 miles west of the intersection of Route 614, Grapefield Rd and the County Line at an unidentified census boundary line where census blocks 1009 and 1014 intersect the County Line; thence west with the line following the northern boundary of census blocks 1014, 1056, and 1019 to a point on ridge of Rich Mountain; thence southwest along ridge of Rich Mountain also being the intersection of census blocks 1030, 1029, and 1031; thence north along the eastern boundary of census blocks 1031 and 1024 to a point intersecting South Fork Clinch River; thence following South Fork Clinch River west to a point intersecting an unnamed creek just west of the intersection of Route 61, Gratton Rd and Elizabeth Rd also being the intersection of census blocks 1025, 2043, and 2042; thence north along the eastern boundary of census block 2042 to the intersection of census blocks 2042, 2032, and 2000; thence following the boundary edge of census block 2032 northeast to a point on the western end of Buckhorn Mountain also being the intersection of census blocks 2000, 2032, and 2010; thence northeasterly 10.2 miles to intersection with West Fork Cove Creek; thence following West Fork Cove Creek northwesterly to its intersection with Oneido Branch; then north on Oneido Branch to intersection with Nye Valley Rd; thence west on Nye Valley Rd to intersection with an unnamed road being the intersection of census blocks 2057 and 1000; thence following the northeastern boundary of census block 1000 northwesterly to its intersection with Oneida Peak Rd; thence following Oneida Peak Rd to its intersection with Cove Creek Rd; thence following Cove Creek Rd east to the point of beginning.



## Falls Mills Precinct

Beginning at a point where Route 656 Unity Rd and Route 643 Mud Fork Rd intersect; thence southeasterly 0.79 miles to an intersection with a stream in a curve of the road at the intersection of census blocks 1035 and 1037; thence following the southern boundary of census block 1037 easterly to the intersection with an unnamed trail north of the terminus of Gulfport Dr; thence following the unnamed trail that proceeds north to the top of the Stony Ridge; thence following Stony Ridge east for 1.5 to an intersection with an unnamed trail; thence following an unnamed road in a northerly direction down the slope to a stream thence following the stream north to its intersection with Tonka Dr; thence along Tonka Dr easterly to its intersection with Route 694; thence along Route 694 to its intersection with Route 102; thence northeasterly along Route 102 to its intersection with Tech Rd; thence northeasterly along Tech Rd to its intersection with Bluestone River; thence north along the Bluestone River 300 feet to an intersection with an unnamed stream on the east side; thence following the unnamed stream northeasterly, paralleling Anita Dr, to the point where it intersects with the Virginia – West Virginia State Line; thence proceeding northwest with Virginia - West Virginia state line to a point 0.15 miles north of the intersection of Route 102, also being the east intersection of census blocks 1046 and 1021; thence proceeding westerly along the southern border of census block 1021 to a point where census blocks 1021, 1081, and 1027 intersect; thence following the northern boundary of 1081 west to intersection with Route 696. Big Branch Rd also being the intersection of census blocks 1081 and 1056; thence following the northern boundary of 1056 southwesterly and continuing southwesterly with the northern boundary of census block 1051 crossing Route 702 Pauley Rd; thence continuing southwesterly with boundary of census block 2018 to a point on Abbs Valley Ridge where census blocks 2004, 2018, and 2015 intersect; thence following down the mountain southwesterly with the eastern boundary of census block 2015 to intersection with Route 643, Mud Fork Rd; thence following Route 643 southwest to point of Begin.

## Freestone Precinct

Beginning at a corner of the Smyth County-Tazewell County boundaries due north of the headwaters of Little Tumbling Creek; thence proceeding northeasterly with the top of the Clinch Mountain approximately 17½ (seventeen and one-half) miles to its intersection with Garden Mountain; thence proceeding southerly with the meanders of Garden Mountain to the Bland-Tazewell County Line on Chestnut Ridge near the Chestnut Ridge Fire Tower; thence southwesterly along Chestnut Ridge with the Bland-Tazewell County Line to a point near the *head* of the right fork of Roaring Fork Creek; thence proceeding southeasterly with the Bland-Tazewell County Line to a convergence of the Smyth County, Tazewell County, and Bland County boundaries; thence proceeding southwesterly along Grape Ridge Mountain, Little Brushy Mountain and Brushy Mountain with the Smyth-Tazewell County Line to a corner in this line approximately ½ (one-half) mile west of Route 91; thence proceeding northerly along the Smyth-Tazewell County Line to the point of beginning.

## Graham Precinct

Beginning at a point of convergence with the Mercer/Bland and Tazewell County lines, also being Bluefield Corporate Limits boundary line; thence following Virginia – West Virginia State Line northwesterly to a point where a stream intersects just north of the terminus of Anita Dr; thence following the stream west, paralleling Anita Dr to an intersection with Tech Dr; thence following Tech Dr westerly to the intersection with Route 102 Falls Mill Rd southwesterly to intersection with Route 694 Hight St thence following Route 694 south to intersection with Tonka Dr; the following Tonka Dr west 130 feet to intersection with an unnamed stream; thence south with stream to an unnamed trail; thence continuing south with unnamed trail to Stony Ridge; thence following Stony Ridge 0.35 miles to an intersection with an unnamed trail; thence winding southerly along said trail to a point just north of Poe St; thence following a line to the west for 0.25 miles to a point just north of a corner of the Bluefield Corporation limits near the intersection of Stoney Ave and Maple St; thence southerly to a corner of the Bluefield Corporation limits near the intersection of Stoney Ave and Maple St; thence southerly along the Bluefield Corporation limits to its intersection with US 19; thence proceeding southwest along US 19 to intersection with US Route 460; thence southwest along US Route 19/460 0.8 miles to point where Bluefield Corporation limits turns south off US Route 19/460; thence following the Bluefield Corporate Limits to the intersection of the Bluefield Corporate Limits and the Tazewell County – Bland County Line; thence following the Tazewell County – Bland County Line easterly to the point of Beginning.

## Indian Valley Precinct

Beginning at a point where Route 758, Franklin Rd intersects the Virginia-West Virginia State line; thence northeasterly along the Virginia-West Virginia State line to a point intersecting an unidentified census block line at the northeast corner census block 1009; thence southeast along the eastern boundary of census blocks 1009, 1011, 1009, and 1010 to intersection with Route 644, Boissevain Rd; thence continuing southeast with unidentified census block line being the eastern boundary of census block 1028 to intersection with Route 658 Rosenbaum Rd; thence continuing southeast with unidentified census block line being the eastern boundary of census block 1027 to point 430 feet east of Route 696 Big Branch Rd where census blocks 1027, 1021, and 1081 intersect; thence following the southern boundary of census block 1027 to the intersection with Route 696; thence following the northern boundary of 1056 southwesterly and continuing southwesterly with the northern boundary of census block 1051 crossing Route 702 Pauley Rd; thence continuing southwesterly with boundary of census block 2018 to a point on Abbs Valley Ridge where census blocks 2004, 2018, and 2015 intersect; thence following the northern boundary of census block 2015 along Abbs Valley Ridge to intersection with Route 655 Goss Rd; thence continuing southwest line with the northern boundary of census block 1022 to intersection with Fargo Rd; thence continuing southwest line with northern boundary of census block 1020 to a point where census blocks 1020, 1014, and 1015 intersect; thence northerly in a straight line with the western edge of the following census blocks: 1015, 1007, 1006 (intersecting Route 644), then 1004 and 1001 to the Virginia-West Virginia State line; thence easterly with Virginia-West Virginia State line to the point of Beginning.

## Jeffersonville Precinct

Beginning at the point on Short Mountain also being the southwestern corner of census block 2005; thence proceeding northeasterly following the western boundary of census blocks 2005 to intersection with Basketball Rd also being the intersection of census blocks 2005, 2010, and 2006; thence following the boundary of census block 2005 southeast and then northeasterly, to the intersection with Route 610 Indian Paint Rd also being the intersection with census block 3002; thence following the western boundary of census blocks 3002, 3000, 4081, and 4013 to a point on the western most top of Paint Lick Mountain, 0.5 miles east of Route 610; thence proceeding northeasterly along the top of Paint Lick Mountain to a point located due north of Bundy's Chapel in Witten Valley; thence proceeding due north, passing through the old quarry at Maxwell, to a point on in the middle of the Clinch River; thence north along the western boundary of census block 1016 to a point on top of Smith Ridge approximately 600 feet east of Route 637; thence proceeding easterly along the southern boundary of the following census blocks: 1015, 1004, 1020, 1006, 1004, 1008, and again on 1004 to a point intersecting an Appalachian Power Transmission Line north of the Clinch River, northeast of Pisgah; thence proceeding northeasterly with the Appalachian Power Transmission Line to its intersection with Route 635 at Hubble Hill; thence following Route 635 south to the intersection with the Corporation limits of the Town of Tazewell; thence following the Corporation limits of the Town of Tazewell easterly to the intersection with Route 16; thence following Route 16 northerly to a point where it intersects with an unidentified census block line being the intersection of census blocks 2000, 1000, and 2005; thence following the southern boundary of census block 2000 to point where it intersects Route 831, Whitley Branch Rd, also being the point where census blocks 2000, 2006, and 1040 intersect; thence proceeding northeasterly along northern boundary of the following census blocks: 2006, 1040, 1041, 1042, and 1035 to intersection of Route 651 and Route 650 at Witten's Mill; thence proceeding southerly along Route 650 to its intersection with Trestle Rd; thence along Trestle Rd and an unnamed drive to intersection with Falcon Ln; thence northerly with Falcon Ln to intersection with Route 649 Lynn Hollow Rd; thence easterly along Route 649 0.64 miles to intersection with an unnamed trail; thence southeasterly with the unnamed trail to intersection with Bluestone River; thence southwesterly with Bluestone River to intersection with westbound lane of Route 19-460; thence west with the westbound lane of Route 19-460 0.36 miles to a point and then crossing the median to the eastbound lane of Route 19-460 and then another 40 feet to a point intersecting an unnamed road; thence following the unnamed road south 350 feet to an unnamed stream; thence following the unnamed stream upstream, which is the southern boundary of census block 1034, to the to a point just south of a peak, thence following a straight line east 0.55 miles to a point on the ridge at Dial Rock being the intersection of census blocks 1034, 1030, and 2010, thence south along the western boundary of census block 2010 0.87 miles to a point on the western end of Buckhorn Mountain also being the intersection of census blocks 2000, 2032, and 2010; thence following the eastern boundary of census block 2000 southerly to the intersection with Route 61 Gratton Rd and then across the road with a creek to intersection with South Fork Clinch River;

thence easterly with South Fork Clinch River 0.37 miles to an intersection with an unidentified census block line; thence following the eastern boundary of two census blocks 1026, crossing Rich Mountain Ln, and block 1029 to a point on Rich Mountain, also the point where precincts Clear Fork, Burkes Garden, Jeffersonville, and Thompson Valley meet; thence following Rich Mountain ridge southwesterly for 5.9 miles to a point south of an unnamed creek; thence following the unnamed creek down the mountain along the eastern boundary of census block 1069 to intersection with Route 16, then crossing to intersection with Plum Creek; thence westerly with Plum Creek to intersection with an unnamed creek; thence following the unnamed creek southerly along the eastern boundary of census block 1002 to Knob Mountain; thence following Knob Mountain southwesterly to a point in the southwestern corner of 1002; thence north and northwesterly along census block 1002 to a point where census blocks 1002, 1004, and 1003 intersect; thence in a straight line west 0.5 miles to intersection with Dorsey Ln; thence south along Dorsey Ln and then with the eastern boundary of census block 1006 and 1025 to intersection with Maiden Spring Creek; thence westerly with Maiden Spring Creek to intersection with Route 608 Hogback Rd; thence south along Route 608 to intersection with Route 91 Maiden Springs Rd; thence westerly with Route 91 to intersection with Route 608 Cove Rd; thence southwesterly with Route 608 0.36 miles to intersection with an unnamed creek and intersection of census blocks 2005 and 2041; thence southwesterly with southern boundary of census block 2005 and then the ridge of Short Mountain to the point of Beginning.

## Jewell Ridge Precinct
