PUBLIC HEARINGS

An Ordinance to require reimbursement for expenses and costs resulting from hazardous materials incident response

The Board discussed the ordinance for which a public hearing was held in May. According to Chase Collins, Supervisor Plaster confirmed that each fire department has sufficient billing practices to be able to collect the reimbursement for hazardous materials and will be responsible for such.

Supervisor Gillespie opened the floor for public comment regarding said Ordinance. Calling three times for public comment, no comments were offered and the public hearing was closed.

Upon motion of Supervisor Plaster, seconded by Supervisor Gillespie and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby adopts the Ordinance. Said Ordinance will be sent to MuniCode and a copy of the Ordinance shall be made a part of the minutes and available in the County Administration Office at 197 Main Street, Tazewell, Virginia 24651.

Trail improvement at Cavitts Creek

Chase Collins explained the process for application and use of federal funds to implement trail improvement. He advised if anyone has any concerns or questions regarding environmental issues related to the project, they should contact Kenneth Dunford, Director of Engineering for Tazewell County no later than June 21, 2022 in order to read those comments into the record at the June 28, 2022 meeting.

Supervisor Gillespie opened the floor for public comment regarding said Ordinance. Calling three times for public comment, no comments were offered and the public hearing was closed.

Mr. Collins reminded everyone that no vote will be taken at this meeting as additional advertisement is necessary before a second public hearing on June 28, 2022 at which time a vote can be taken.

FY23 proposed budget: Consideration of approving the FY2023 budget at the June 28, 2022 meeting

Supervisor Gillespie opened the floor for public comment regarding the proposed FY23 budget. Calling three times for public comment, no comments were offered and the public hearing was closed.

Chase Collins informed everyone of the requirement that the budget be advertised two times, the second of which must be advertised at least 7 days after the first advertisement to allow revision to be made.

CITIZEN COMMENTS SCHEDULED

Frank Nolley (550 Williams Street, Bluefield Virginia (Abbs Valley) 24605) asked about the possibility of extending the 5 mile trailhead access on paved roads to include several new businesses in the Abbs Valley area, expressing concern that the lack of that access is affecting those businesses and deterring ATV guests from patronizing that area because TCSO is issuing citations to riders unlawfully riding on the paved road. Eric Young, County Administrator and Supervisor Asbury both explained that the county cannot make that extension without the trailhead itself being extended.

Mr. Nolley presented a petition, which was made a part of these minutes and made available in the County Administrator's Office at 197 Main Street, Tazewell, Virginia 24651.

UNSCHEDULED CITIZEN COMMENTS

Brian Beckt (PO Box 10, Pounding Mill, Virginia 24637) from Appalachian Agency for Senior Citizens informed everyone that current AASC Executive Director, Regina Sayers will begin her retirement on or around September 30, 2022 and he has been named as Director for AASC once that happens.

Mr. Beckt gave highlights of AASC's services and successes and thanked the Board for their continued support and assistance.

ADMINISTRATIVE/FINANCIAL/COUNTY PROJECTS UPDATE

Consideration of holding a public hearing to consider an ordinance to permit travel on a state route near Richlands

Chase Collins advised that he was approached by Spearhead about the possibility of extending the Jawbone trail through Jewell Ridge, Jewell Ridge Camp, an additional road and Briar Patch Road, into Route 67. The Board briefly discussed the Town of Richlands places for allowing ATV traffic on routes near Richlands.

Upon motion of Supervisor Plaster, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby votes to hold a public hearing regarding extension of the Jawbone trail to permit travel on VDOT routes near Richlands.

Reassessment

Mr. Young announced that an advertisement for proposals from firms qualified to conduct Tazewell County real estate reassessment was done and responses received from four (4) firms. There is a requirement that no more than two (2) Board members may serve on a committee. He asked that the Board form a committee to interview proposers and revisit the Board.

Upon motion of Supervisor Hrovatic, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby approve Supervisor Plaster, Supervisor Gillespie and Commissioner of Revenue David Anderson to serve on the Committee.

Consideration of holding a public hearing - tax exemption request for SWCC Foundation - student housing

Mr. Young in formed the Board that the SWCC Foundation, a non-profit organization, is constructing student housing near the SWCC campus and requests a tax exemption for that property for so long as it is used for student housing.

Mr. Collins and Mr. Young discussed the application process and that it requires a public hearing.

Supervisor Hrovatic disclosed that he is a member of the Foundation board and will abstain from discussion and voting.

Upon motion of Supervisor Gillespie, seconded by Supervisor Plaster and adopted by a vote of 4 to 0, with all members present, Supervisor Hrovatic abstaining and no one against the same, the Tazewell County Board of Supervisors hereby votes to hold a public hearing regarding granting tax exemption for the SWCC Foundation's student housing property.

Consider appropriating \$240k from FY22 Budget to SWCC for FY22 scholarship program, which includes \$11,000.00 to be applied to the FY23 program

Eric Young explained that Budgeted approximately \$240K for scholarships to SWCC – the actual amount turned out to be slightly more than \$228,000.00. It's difficult to always know the amount because the academic year runs differently that the county's budget year and the number of students eligible for the scholarship is unknown at the time of our budget release. Because this amount is approximately \$11,000.00 less than budgeted, he suggested that the full \$240K be paid, allowing SWCC to carry over the \$11,000.00 excess to next year, allowing us to budget the same amount of money each year.

Upon motion of Supervisor Plaster, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby votes to pay \$240,000.00 to SWCC for scholarships.

Burkes Garden Fire Department – Thompson Foundation Grant

Eric Young shared that the Burkes Garden Fire Department applied for a \$45,000.00 grant through the Thompson Foundation. One condition of the grant is that the Department raises a matching \$45,000.00 and uses the proceeds of the sale of their current building toward the new construction. The estimated cost of building the new structure is \$130,000.00 to \$150,000.00. The Thompson Foundation asks that the County act as the grant manager for the project. Mr. Young will meet with Fred Lawless of the Burkes Garden Fire Department to review the building budget.

Upon motion of Supervisor Stacy, seconded by Supervisor Gillespie and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby agrees to serve as the fiscal agent for the Thompson Foundation grant for the Burkes Garden Fire Department.

Vacation of North Street (Doran off of Kirby Rd) - Consideration of holding public hearing to rescind

Chase Collins reminded the Board that in March 2022, a public hearing was held to vacate an alley platted as North Street off of Kirby Road in the Doran area. The vacation was approved. Prior to the recording of the deed of vacation, the resident who requested the vacation called to request that the vacation be rescinded.

Eric Young explained that, at the public hearing, the residents were repeatedly informed of the consequences of the vacation, which would split the alley between them and the neighbors and essentially divide a structure owned by them.

Mr. Young recommended that we give direct notice to the adjacent property owner of the intention to have a public hearing to give that property owner an opportunity to object.

Upon motion of Supervisor Stacy, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby votes to hold a public hearing to rescind the

vacation on the condition that Mr. and Mrs. Dales pay the advertising expenses for the public hearing.

Ratify the Fire/EMS Agreement with Bluefield, Virginia

Eric Young explained the relationship with Tazewell County and Town of Bluefield regarding emergency services. He advised that the County provides EMS in the Town and the Town provides fire protection in the County. He said this has been the arrangement for many years and the contract simply documents it.

Upon motion of Supervisor Stacy, seconded by Supervisor Gillespie and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby votes to ratify the Fire/EMS Agreement with the Town of Bluefield, Virginia.

Mr. Young requested that the agreement be made a part of the minutes and a copy be made available in the County Administrator's Office at 197 Main Street, Tazewell, Virginia 24651. The Chair ordered that the agreement be made a part of the minutes.

ADP Software Service Consideration

The annual cost will be approximately \$63,000.00, but will be offset by the elimination of that payroll position.
