Chairman Gillespie opened discussion regarding the Pro Life Sanctuary Resolution by reading the proposed resolution entitled "Sanctuary of the Unborn", and then delivered the following statement:

#### **VOICES WE REPRESENT**

Tonight, on the 6<sup>th</sup> of September, this Board has convened to make decisions that impact the residents of Tazewell County.

As a member of this board, duly elected by the residents of the Southern District, I have an obligation to respond to requests made by my constituents. As it should be for any representative, it ought to be the happiness and glory of us to live in the strictest union, the closest correspondence, and the most unreserved communication with our own constituents. Their wishes should bear great weight upon our shoulders, their opinions should be met with high respect; and their business should be provided unremitted attention. It is our duty to sacrifice our repose, pleasure and satisfaction to the constituency's desires and interests.

To that end, we as a Board have on our agenda resolution titled: Sanctuary for the Unborn. This resolution represents a constituency's appeal to provide a unified voice for those who cannot speak for themselves. Before my comments, I would be derelict in my duties if I chose not to reveal some of the sources that support my position. My statements have been motivated by far greater leaders than myself. Examples include the Right Honorable Edmond Burke of England, President George Washington the late Justice Antonin Scalia of the Super Court of the United State, Governor Patrick Henry of Virginia and others. I give them credit, as it is deserved, for providing a foundation upon which we may stand.

First, we should represent the voice of all beings who value life, liberty and the pursuit of happiness. I first turn the language of a document that altered the world - the Declaration of Independence as adopted July 4, 1996. It, I part, states, "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty and the pursuit of happiness. That to secure these right, Governments are instituted amount among men, deriving their just powers form the consent of the covered, -That whenever any form of government becomes destructive of these ends, it is the right of the people to alter or to abolish it, and to institute new government, laying its foundation on such principles and organizing its powers in such form, as to them that seem most likely to affect tehri Safety and Happiness". This Board, as evidenced by the Code of Virginia and the Constitution of Virgnia, has every ingredient to be included in the "Governments (that) are instituted' amongst men, women, and children. Our Board has the duty to ensure "safety and happiness". Moreover, our Board has every ingredient to be considered part of the American Constitutional Republic and Commonwealth system of Virginia and this fact mandates us, as representatives, to protect the "unalienable rights that among these are life, liberty and the pursuit of happiness".

Second, we should present the voice of The Posterity. I turn to the great Constitution of Virginia, Article I, Sec. 1 of our Bill of Rights states, "That all men are by nature equally free and independent and have certain inherent rights, of which, when the enter into a state of society, they cannot, by any compact, deprive or divest of their posterity; namely, the enjoyment of life and liberty, with the means of acquiring and possessing property, and pursuring and obtaining happiness and safety". Those present here tonight are not the only individuals that are provided protection under Article I, Sec. 1 of our Bill of Rights. When you take this text, as simply stated, it clearly qualifies "men" (men, women and children) with "all". The construction of this phrase leads to only one logical conclusion: that if you can be defined as a person, then you are entitled to protection of your life, liberty, happiness, and safety. However, this protection does not cease upon your condition of being a man, woman or child. The Virginia constitution goes on to guarantee this protection to "The Posterity" - the generations not yet known. Little may

know that the etymology of the word "posterity" reveals its origins from the Latin word *posteritas, posterus,* or even *post.* Etymologists have provided basic definitions or explanations for these ancient words; they have stated the word means following, next, or coming after. Etymologist have also highlighted the word's prominence in the late 14<sup>th</sup> century French language At that time, the French used the word *posterite*` which can be defined as offspring or descendants. There is not great etymological leap from the 14<sup>th</sup> Century French word to the word utilized by the authors of the Virginia Constitution and Bill of Rights, notable the Delegate George Mason of Fairfax.

Likewise Patrick Henry, in 1788, delivered a speech at the Virginia Convention Debate concerning the ratification of the Constitution. In part, he stated, "...the voice of tradition, I trust, will inform posterity of our struggles for freedom. If our descendants be worthy the name of Americans, they will preserve and hand down to their latest posterity, the transactions of the present times; and though, I confess, my exclamations are not worthy the hearing, they will see that I have done my utmost to preserve their liberties". Henry understood the importance of The Posterity and desired to do what he could to "preserve their liberty". The Posterity, as referenced in our Constitution and by Patrick Henry, is comprised of all beings, men, women and children of all colors, shapes and sizes, regardless of age, development or stature – those that are living now and more importantly those children who are the future. The voices of The Posterity we must represent.

Finally, we should represent the voices of those who cannot speak for themselves. Our common sense and human civility compels us to do so. I need not remind anyone in the room of the tragedies this County has faced since its inception and I acknowledge, with great sorrow, that some are still suffering at the hands of nature by means of rain and flooding. But what do we do to those that are in need or cannot help themselves? We, as representatives, use our voice and pray to become a beacon of hope. We, as representative, desire to open our mouths for the mute, open our eyes for the blind, walk for the crippled, be ears for the dear and provide shelter for those that have none. I'm sure my other colleagues agree with me that our goal – why each of use decided to participate in government as elected officials – is to help others. Of people we wish to help, our children have great priority. They are our future. They are the They will carry on the torch of freedom. gateway to innovation. Regardless of their age, where they come from or who they are our children deserve a voice if and when no one else will speak on their behalf. It is now our time and place to be a voice for children that, because of no fault of their own, are subjected to the depraved or difficult decisions. Conviction and duty command me to represent those who have no voice - every child is fight worthy of unrelenting attention consistent support and unwavering protection.

Thus, my response to the constituents of the Southern District in Tazewell County, as their representative, concludes with resounding support for the Resolution. The people I represent overwhelmingly support being a voice for life now and for ages to come and I will gladly and humbly bend to their will.

In conclusion, I support the notion that the unborn deserve a voice even if it is only here in Tazewell County, Virginia. I present this plea with the same hope that President George Washington possessed when proving his inaugural address in 1789. He stated, "I dwell on this prospect with every satisfaction which an ardent love for my Country can inspire; since there is no truth more thoroughly established than that there exists in the economy and course of nature an indissoluble union between virtue and happiness, between duty and advantage, between the genuine maxims of an honest and magnanimous policy and the solid rewards of public prosperity and felicity; Since we ought to be no less persuaded that the propitious smiles of Heaven can never be expected of a nation that disregards the eternal rules of order and right, which Heaven itself had ordained. And since the preservation of the sacred fire of liberty and the destiny of the Republican model of Government are justly considered as deeply, perhaps as finally staked on the experiment entrusted to the hands of the American people:. We, even here in the mountain of southwest Virginia are still part of the ongoing "experiment entrusted" to the posterity of our nation and our County in which all voices should be represented and all life protected as regulated by the "eternal rules of order and right".

With so little said and so much to do, I now beg my colleagues on this pulpit of the public to pass the resolution so carefully drafted and artfully debated. It is our time to ensure all voices are represented.

Supervisor Stacy stated that he felt he had not been given enough time to review the resolution and he felt the Board could do more than just words. He called to action in addition to the resolution.

The Chair then called for further comments on the resolution. Supervisor Plaster was recognized and suggested a committee be formed to coordinate support services to facilitate women choosing life.

Supervisor Stacy requested that a public hearing be held in October so that the public could comment more fully. Chairman Gillespie directed that the notice of public hearing be advertised in The Clinch Valley News and Press, The Voice and the Bluefield Daily Telegraph.

Upon motion of Supervisor Plaster, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the

Tazewell County Board of Supervisors agrees to form a committee to identify resources and educational information to women in hopes of steering them away from abortion.

## ADMINISTRATIVE/FINANCIAL/COUNTY PROJECTS UPDATE

#### Discussion regarding former animal shelter property

County Administrator, Eric Young, relayed to the Board the poor condition of the animal shelter and suggestions that had been made for its use. He said that based on staff recommendations, the old shelter should be demolished.

The Chair directed that the County Administrator obtain demolition quotes and report at the October 4, 2022 meeting.

#### Discussion regarding EV charging stations

Fred Lawless spoke regarding the cost of installing an electric vehicle (EV) charging station in Burkes Garden. Mr. Lawless stated the cost of the unit and installation from State Electric in Bluefield, Virginia is approximately \$4,000.00 and the service will be free of charge to the public. He said the charging station is activated by using a credit card, which will allow a two hour charge, but will not allow the same vehicle to be charged more than one time in a 24/48 hour period. According to Mr. Lawless, the Burkes Garden Telephone Company is willing to assist at no charge. The Chair directed that Chase Collins, County Attorney, prepare a contract to that effect.

The Board discussed other potential locations for charging stations. The County Administrator said he advised against getting in the charging station business and suggested the County contract with Burkes Garden Telephone Company to operate the EV station.

Upon motion of Supervisor Gillespie, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors approve the amount of \$5,000.00 to be paid to the Burkes Garden Telephone Company upon execution of a contract in accordance with the terms set forth in the Minutes as approved by the County Attorney (\$4,000.00 to State Electric for the purchase of the charging station and \$1,000.00 to the BGTC for its willingness to monitor/service the charging station).

## Firefighter's stipend

Eric Young outlined the firefighter's tax credit and the firefighters stipend and recommend that the tax credit be abolished in order to pay a stipend to only the firefighters who respond to calls. He said this would allow the County to increase the amount of the stipend.

The Board discussed Mr. Young's request. Mr. Stacy stated he would prefer not to take anything away from firefighters and asked the Chair to direct the Budget Committee to meet to see if more funding could be found for stipends. The Chair agreed and asked the Budget Committee to review the matter.

## Disaster Relief Fund policy discussion

Eric Young presented a summary of the recommendations coming out of the Disaster Relief Committee, including that the Board establish an annual budget in the amount of \$55,000.00 for FY2023 for administrative costs and for relief to be paid to eligible households whose homes were rendered uninhabitable by a qualifying event. He also recommended that an additional \$50,000.00 be budgeted for emergency management for FY2023 to be used for immediate needs of food/water/toiletries/etc as well as preventative measures, such as keeping culverts/bridges free of debris and keeping ditches pulled.

A copy of Mr. Young's presentation is hereby made a part of the record and a copy is available in the County Administration Office, 197 Main Street, Tazewell, Virginia 24651.

The Chair directed that a resolution detailing the plan be drafted for the October meeting.

#### Supervisor Emergency Management Training

The County Administrator advised that the Virginia Department of Emergency Management (VDEM) offers training that Board members can take advantage of if they wish. That training will be offered at the October meeting beginning at 3:00 pm for those Board members desiring to attend.

#### **Reserve fund recommendations**

Supervisor Stacy asked that the County Administrators recommendation be reviewed by the budget committee before presented to the full Board. Chairman Gillespie tabled the presentation.

#### Crooked Road expansion – bluegrass music

Supervisor Gillespie shared that he wishes to renew the promotion of the Crooked Road, bluegrass music and our local fiddler's convention.

## Town of Tazewell Police Department – Shop with a Cop donation request
