<u>NEW BUSINESS:</u> OCS November Calendar – The calendar was reviewed by the Team noting ChildFirst Virginia Forensic Interview Training; scheduled for November 1, 2021 thru November 5, 2021.

OCS Internal Control Worksheet – The Team completed the yearly Internal Control Worksheet and Questionnaire. This assessment is usually completed by July of each year due to the pandemic it was not possible to meet the July deadline; goal is to complete the assessment again in July 2022. The CSA Coordinator will keep a copy on file of the completed assessment.

OCS Risk Management Worksheet – The Team completed the yearly Risk Management Work sheet and Questionnaire. This assessment is usually completed by July of each year due to the pandemic it was not possible to meet the July deadline; goal is to complete the assessment again in July 2022. The CSA Coordinator will keep a copy on file of the completed assessment.

CQI – The Team reviewed the Continuous Quality Improvement Information available from FY 2017 through September FY21. The information reviewed included Total Net Expenditures, YTD Net Expenditures, ICC, CBS, Foster Care Statistics and Distinct Child Count by Service Placement Type. There was much discussion about the available statistics, including exactly which charts and how often reviewing the information would be most beneficial. The Team requested the CSA coordinator pull the same CQI information for the meeting in November along with the information of two nearby localities for comparison.

<u>Closed Meeting</u> – Lori Gates-Addison made a motion that the CPMT go into Closed Session to discuss cases for Foster Care, CPS, Cumberland, Court Services, Tazewell County Schools and funding to be provided for services for these cases. The motion was seconded by Edwinna Crawford and unanimously carried.
