Upon motion of Supervisor Stacy, seconded by Supervisor Gillespie and adopted by a vote of 4 to 0, with Supervisor Asbury absent, the Tazewell County Board of Supervisors hereby authorizes Republic to accept the low bid from Ampeco for construction of the next cell at the landfill in the amount of \$4,974,686.00.

Upon motion of Supervisor Plaster, seconded by Supervisor Gillespie and adopted by a vote of 4 to 0, with Supervisor Asbury absent, the Tazewell County Board of Supervisors hereby rescinds the December 2022 resolution regarding the allocation and appropriation of the FY22 ending balance, except the \$500k allocation for district capital funds and reallocate the remainder to the FY22 ending balance to the FY24 beginning balance.

Eric Young stated he received a request for funding from AASC for \$4000.00 for the purchase of a stove/range.

Upon motion of Supervisor Plaster, seconded by Supervisor Gillespie and adopted by a vote of 4 to 0, with Supervisor Asbury absent, the Tazewell County Board of Supervisors hereby approves a donation from the Western District funds in the amount of \$4000.00 from contingency AASC for the purchase of a stove/range. The County Administrator is hereby authorized and directed to issue said warrant in accordance with this action and which said warrant will be converted to negotiable check by the Treasurer of Tazewell County, Virginia.

Mr. Young also asked that the Board renew the contract with USI, the County's insurance consultant, for one year for a fee of \$50,000.00.

Upon motion of Supervisor Hrovatic, seconded by Supervisor Gillespie and adopted by a vote of 4 to 0, with Supervisor Asbury absent, the Tazewell County Board of Supervisors hereby approves the contract with USI for one year at a cost of \$51,000.00. The County Administrator is hereby authorized and directed to issue said warrant in accordance with this action and which said warrant will be converted to negotiable check by the Treasurer of Tazewell County, Virginia.
