#### **ABSENT:**

Chairperson, Shanna Plaster called the regular meeting to order and presided.

Supervisor Stacy led The Pledge of Allegiance to the United States flag followed by the invocation given by Supervisor Gillespie.

Chairperson Plaster welcomed those in attendance and citizens who were participating by conference call. Citizens were able to call in and participate in the meeting by calling (425) 436-6388 and entering the access code 836650.

County Administrator, Eric Young explained the purpose of the recessed meeting, which is to consider a flood study conducted about Tazewell County's flooding issues by First Earth/RES. He explained that the purpose of having the study done is to be able to reach out for grant opportunities to remediate causes of flooding in the County. Charles Westbrook will present excerpts of the study during the meeting and will participate in this meeting to answer any questions that might arise.

Upon motion of Supervisor Gillespie, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors agree to suspend Roberts Rules of Order to allow the Board to move about in the agenda as it becomes necessary in the meeting.

#### AGENDA APPROVED AS AMENDED

The Chairperson called for any additions to the agenda.

Upon motion of Supervisor Stacy, seconded by Supervisor Gillespie and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors approved the August 8, 2023 revised agenda with additions/deletions, a copy of which is available at the County Administration Office, 197 Main Street, Tazewell, Virginia 24651.

#### **PUBLIC HEARINGS**

The Chairperson announced the special presentation by First Earth/RES, the firm that prepared the flood study for the county.

County Administrator, Eric Young, explained that the study will be used to apply for grants to help alleviate flood issues in the county.

#### Public hearing regarding First Earth Flood Study

The Chairperson called to order a public hearing that was duly advertised according to law regarding the First Earth Flood Study

Now, the Chairperson called for public comments from the floor three times with regard to the public hearing.

**Flora Horton Sinkford** – 208 Blacksburg St., North Tazewell, VA 24630.

Ms. Sinkford spoke regarding the flooding difficulties experienced by the Blacksburg community.

Gertrude Taylor – 174 Blacksburg St., North Tazewell, VA 24630.

Ms. Taylor spoke regarding how a flooding situation affects the handicapped residents of the Blacksburg community.

Calvin Goddard – 163 Blacksburg St., North Tazewell, VA 24630.

Speaking on behalf of his brother, Cicero Goddard, Calvin Goddard stated that his family has seen flooding over the course of many years and feels there are several reasonable solutions to the flooding.

There being no further comments, the Chairperson declared the public hearing closed.

Charles Westbrook of First Earth/RES shared an online presentation with information pertinent to Tazewell County and its particular flooding situations. The presentation included pinpointing causes of flooding in particular areas of the County as well as possible solutions, estimated costs of those solutions and possible grants that may be available to help with those solutions. Because there were several citizens from the Blacksburg community present at the public hearing, the focus of the presentation was on that area so those citizens were able to contribute their thoughts as to possible solutions.

Mr. Young shared several public comments that were received online and asked that a copy of the printout of those comments be made a part of the minutes of these minutes. A copy is available at the County Administration Office, 197 Main Street, Tazewell, Virginia 24651.

Supervisor Stacy spoke about flood prevention in areas that might be better protected if some debris was cleaned out of some of the creeks. Dave Whtie, Director of Operations explained that equipment cannot enter into creeks or rivers but the bucket of an excavator or other equipment is permitted to scoop debris.

Ms. Sinkford mentioned that the Corps of Engineers will assist if an invitation is extended to them. Supervisor Stacy asked Mr. Dunford to extend an invitation to the Corps of Engineers to come to a public meeting.

Supervisor Stacy and Supervisor Gillespie lead a discussion regarding eradicating the beavers in the Blacksburg community.

Upon motion of Supervisor Gillespie, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors approved adopting the flood study as presented as a flood remediation plan.

# **DEFERRED ITEMS AND NEW BUSINESS**

County Attorney, Chase Collins recited the items on the agenda that were deferred from the August 8, 2023 meeting as well as new business for the current meeting.

The Chairperson added a request for funding to TRIAD through AASC.

The County Administrator requested to defer Items 2, 3 and 4 in the Administrative section to the September 12, 2023 agenda.

Upon motion of Supervisor Hrovatic, seconded by Supervisor Asbury and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors approved deferring Items 2, 3 and 4 in the Administrative section of the agenda until the September 12, 2023 meeting.

Eric Young inquired as to whether the meeting will proceed using the current agenda, then add the new items at the end of the meeting or weave the new items into the meeting as they come about. Supervisor Hrovatic commented it would be best to address new items after the public portion of the agenda has been addressed.

Upon motion of Supervisor Gillespie, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors approved additions to the agenda.

#### ROBERT'S RULES OF ORDER

Upon motion of Supervisor Gillespie, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors approved suspending Robert's Rules of Order for the purpose of moving about the agenda as is necessary.

#### **ADMINISTRATIVE**

Supervisor Gillespie asked whether the issue of the Cove Community Center will be addressed at this meeting or whether it will be addressed at the September 12, 2023 meeting. Mr. Collins advised that the matter will be addressed at this meeting.

#### TRIAD funding request

Supervisor Asbury stated that through some research and conversations with TRIAD representatives, it was determined that the Board can donate to TRIAD through AASC.

Upon motion of Supervisor Asbury, seconded by Supervisor Plaster and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors approved a donation in the amount of \$500.00 as indicated below.

# Clinch River Valley Initiative – resignation of John Absher

The Chairperson directed that this matter be deferred until the September 12, 2023 meeting.

#### RDA – consider rescinding appointment of James Gibson

Mr. Collins stated that James Gibson was appointed in 2022 and was sent an appointment letter, but hasn't been sworn.

Upon motion of Supervisor Hrovatic, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors approved rescinding James Gibson's appointment to the RDA.

#### Cove Community Association

Mr. Collins reminded the Board that a public hearing regarding the Cove Community Association was held on August 8, 2023 at which time, there were no public comments. He stated that the Cove Fire Department is on the parcel of land that the BOS is considering conveying to the Cove Community Association.

Supervisor Stacy asked if this matter has been addressed by the ESC considering that one of the County's fire department's is being proposed. Mr. Collins advised that it is feasible to convey only the portion of the fire department parcel that contains the ingress and egress to the community center. Supervisor Gillespie stated that the issue of ingress and egress is the most important of the request by the Cove Community Association. He asked that a conveyance be made sooner rather than later for the portion of the fire department parcel that contains the ingress and egress to the community center and address the remainder of the fire department parcel at a later date. Mr. Collins showed the parcels on the county GIS to demonstrate how those are situated.

Supervisor Stacy asked for more time to gather additional information as this request would relinquish ownership of one of the County's fire departments to the Cove Community Association, which could jeopardize fire service to that community.

Dave White, Director of Operations, stated he feels like the fire department building is a liability to the County. Mr. Young recommended that the Cove Community Association might agree to a long-term lease if the fire department parcel is conveyed to them. Supervisor Gillespie shared that it is feasible that the fire department parcel be subdivided to only convey the portion of that parcel to the Cove Community Association that contains the ingress and egress.

Upon motion of Supervisor Gillespie, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors agree to defer this matter until the September 12, 2023 meeting.

Mr. Young advised that both Smyth and Tazewell Counties are in the Bristol VDOT District and suggested that contact begin with that office.

# Supplemental funding or Victim/Witness office

The County Administrator advised that the Commonwelaht's Attorney notified him that state budget cuts affected the Victim/Witness office and Mr. Plaster asked for \$10,000.00 to help support the program.

Upon motion of Supervisor Gillespie, seconded by Supervisor Stacy and adopted by a vote of 4 to 0, with Chairperson Plaster abstaining, the Tazewell County Board of Supervisors hereby approves supplemental funding in the amount of \$10,983.00 from contingency for supplemental funding for the Victim/Witness program.

#### Previous surplus bids

Mr. Young shared that there were two ambulances sold with the previous surplus items and these ambulances were never paid for nor retrieved.

Mr. Collins explained that the buyer's representative came and asked for keys to the ambulances and none could be produced, the buyer didn't retrieve them and nothing further was heard from the buyer. He suggested a motion to reject the bids on those ambulances so they can be readvertised and sold.

Upon motion of Supervisor Stacy, seconded by Supervisor Gillespie and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors hereby rejects all previous bids on the two ambulances previously advertised for sale as salvage/surplus.

#### Additional items for surplus list

Mr. Young shared that there are multiple items stored at the landfill that are suitable for surplus.

Upon motion of Supervisor Stacy, seconded by Supervisor Gillespie and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors hereby approves to include the two ambulances in the advertisement for the upcoming surplus sale as well as new additions to the list as attached.

# Firefighter Insurance

Mr. Young recommended changed the firefighter and EMS insurance firm Harfford to VFIS effective September 1, 2023. There will be a small savings of approximately \$100.00 per year, with better coverage that with Hartford.

Upon motion of Supervisor Stacy, seconded by Supervisor Plaster and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors hereby approves changing the firefighter and EMS insurance provider from Hartford Insurance to VFIS.

# Four County Transit contract with AASC
