Upon motion of Supervisor Stacy, seconded by Supervisor Gillespie and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors approved the November 9, 2023 amended agenda with additions/deletions, a copy of which is available at the County Administration Office, 197 Main Street, Tazewell, Virginia 24651.

# **DEPARTMENT REPORTS**

# Engineering – Kenneth Dunford

Mr. Dunford advised that no bids were received for the next phase of the library repair project. Chase Collins, County Attorney, advised that since procurement requirements have been met, it is appropriate for Mr. Dunford to negotiate with engineering firms for estimates and choose from those estimates and hire a firm to perform the remaining work.

Supervisor Hrovatic mentioned that residents on Indian Paint Road have concerns that the speed limit is too high since an additional one-mile portion of that road has been paved. He asked that Mr. Dunford adjust the speed limit to better suit the secondary road.

Supervisor Hrovatic also spoke regarding the flashing yellow signal lights near Claypool Hill that allow drivers turn after yielding to oncoming traffic. He stated that traffic accidents at intersections with those turn/yield lights have increased and asked Mr. Dunford to request VDOT to study the situation.

Supervisor Gillespie spoke about the VDOT work on Route 16 and asked Mr. Dunford if he had any information about the west Riverside Bridge on that route. Mr. Dunford offered to follow up with VDOT on this matter.

Supervisor Asbury spoke regarding handicap access to dumpsters at convenience stations and asked that the subject be revisited and Mr. Dunford offered to do so.

Supervisor Hrovatic asked whether Capital is officially operating the landfill at this time. Mr. Dunford confirmed that Capital is bringing in new equipment and the process is running smoothly so far.

Eric Young stated that the last invoice for Republic's services will need to be prorated because they vacated a day earlier than their contract called for.

Supervisor Plaster inquired about changing the name of Garnet Lane to Williams Drive/Lane. Mr. Collins advised that once the Addressing Department has confirmed there is no other street in the county road system by that name, a public hearing is required to change the name of the street. Mr. Young suggested notifying neighboring residents of the public hearing by certified letter.

Upon motion of Supervisor Plaster seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors hereby approve a public hearing to change the name of Garnet Lane to Williams Drive/Lane upon confirmation that there is no other street in the county road system by that name.

# **Tammy Allison Resolution**

# ADMINISTRATIVE/FINANCIAL/COUNTY PROJECTS UPDATE

#### Nuisance abatement

Eric Young reported that the mobile homes that created the nuisance issue have been removed as part of the flood mitigation project and, therefore, the issue is resolved.

#### Landfill haul bill

Upon motion of Supervisor Plaster, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors hereby ratify the payment for the Cedar Bluff haul bill of \$589.00 which has already been paid.

# 2024 meeting calendar

Mr. Young asked that this matter be addressed at a later date but that the January 2024 meeting be held on January 9 to avoid the holiday.

Upon motion of Supervisor Stacy, seconded by Supervisor Gillespie and adopted by a vote of 5 to 0, the Tazewell County Board of Supervisors hold the January 2024 meeting on January 9 and that the entire 2024 meeting calendar be voted on at a later date.

#### Animal Shelter

Chase Collins advised that the shelter board met in October and will meet again in January to renew the bylaws of the organization.

The Chairperson ordered this matter deferred until the December 2023 meeting.

# Labor of Love – use of fairgrounds

Mr. Young explained the Mission's request for use of the fairgrounds for food distribution. He recommended that the Board donate to Labor of Love a deposit of \$750.00 which would be held until July 2024 and refunded at that time if no damage or additional cleanup resulted from its use. Supervisor Stacy asked why the Board would donate a deposit. The consensus of the Board was that they pay the deposit as anyone else. Mr. Young advised he would send a contract/letter to Labor of Love outlining the usage requirements.

# TCSO weapon upgrade

Mr. Young explained that TCSO has requested approval to trade/purchase/upgrade the weapons currently in use by its officers, which requires Board approval because technically the weapons are county property.

Chase Collins pointed out the quotes offered by several FFL gun dealers meet the county's small purchase procedures.

# ACTION FOLLOWING EXECUTIVE SESSION

The Chairperson asked if there was any action following Executive Session.

#### Landfill

Upon motion of Supervisor Gillespie, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby move that the Tazewell Conty Board of Supervisors approve the portion only of the change order request from Republic Services, Inc. to split the landfill cell construction into two phases (Call 5A-1 and Cell 5A-2), so as to complete a usable portion of the landfill cell prior to Winter 2023 as detailed in a letter for Stoddard Pickrell – Environmental Manager for Republic Services, Inc., dated November 8, 2023.

Pursuant to said request, this motion only authorized additional compensation of up to \$45,000.00 for cell design by Schnabel Engineering as submitted with the above-reference letter dated November 8, 2023. No other additional compensation to the contractor for work described in the above-referenced letter dated November 8, 2023 is authorized at this time.

And upon further motion that the Tazewell County Board of Supervisors defer consideration of the portion of the change order request pertaining to additional compensation for rock removal until such matter may be more thoroughly reviewed by Administration.

# Fairground use agreement regarding horse shows

Upon motion of Supervisor Gillespie, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby allocates up to \$50,000.00 from contingency to match improvements to the Tazewell County fairgrounds to be made by Tazewell Horse Show, LLC and to waive up to three (3) years' rental fees for that organization for consideration for the proposed upgrades.

#### Project Bonanza

Upon motion of Supervisor Asbury, seconded by Supervisor Hrovatic and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby authorizes the County Administrator to authorize up to \$200,000.00 from the Capital Projects fund for the Tazewell County IDA Project Bonanza.

# School facilities

Upon motion of Supervisor Hrovatic, seconded by Supervisor Plaster and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors hereby resolves the following with respect to school facilities

- 1. The commission of a ten-year plan to construct three (3) K-8<sup>th</sup> grade facilities, one in each of the three school districts, each of which shall replace at least three existing schools and complete the procurement of an engineering firm to assist with the plan;
- 2. To authorize Tazewell County Public Schools to apply to the Virginia Board of Education School Construction Assistance Program for a grant of \$15m and financing from the State Literary Loan Program for School Construction in an amount not to exceed \$30m to pay for the first of the three schools;
- 3. To commit, that if the school board is awarded the grant this Board will approve the financing and fund the annual debt service to pay for the remainder of the cost of the new school in excess of the amount of the grant on the conditions that the new school facility shall replace at least three existing school facilities within the same current school district;
- 4. To commit to dedicate such new coal severance tax revenues from the 2025 Coronado mind expansion as may be necessary to fund the debt service on school facility construction and that, should construction be delayed, such revenues be escrowed in reserve until such time as they are needed to fund school construction;

- 5. To direct the County Administrator o work with Tazewell County Public Schools, the architects regained and Davenport Financial to prepare a financing schedule such that the debt service may be incorporated into the FY25 budget;
- 6. That a resolution entitled "A Resolution in Support of Application to the Virginia Board of Education School Construction Assistance Program" be approved, dated November 9, 2023 and authorize the Chairperson and County Administrator to execute the resolution and whatever documents may be necessary to make such application.

County Administrator, Eric Young, explained the particulars of the proposed ordinance.

The Chairperson called to order a public hearing that was duly advertised according to law regarding a public hearing regarding an ordinance for an EMS Loyalty Incentive Program.

Now, the Chairperson called three times for public comments from the floor and being none, the hearing was closed.

Mr. Collins read the specific details of the Ordinance. Mr. Young pointed out that there was an error in the wording. He stated the intent was not to bonus overtime hours worked but part time hours worked.

Upon motion of Supervisor Gillespie, seconded by Supervisor Stacy and adopted by a vote of 5 to 0, with all members present and voting in favor thereof and no one against the same, the Tazewell County Board of Supervisors approved the Ordinance, after an amendment to the Ordinance to provide that part time EMS employees who have worked at least 300 hours in a quarter will receive a \$300.00 bonus for that quarter.

#### **Ordinance regarding Circuit Court Clerk bonus**

County Administrator, Eric Young expressed concern that the money for the proposed clerk's bonus would come from the technology portion of the budget within the TCCC, and he is uncomfortable draining that account for bonuses, explaining that even though it may not be necessary to purchase computers each year, for example, when it does become necessary, the funds would have been depleted by using it for bonuses.

The Chairperson called to order a public hearing that was duly advertised according to law regarding a public hearing regarding an ordinance for Circuit Court Clerk bonuses.

Now, the Chairperson called three times for public comments from the floor and being none, the hearing was closed.

Upon motion of Supervisor Hrovatic, seconded by Supervisor Asbury and adopted by a vote of 4 to 1, with all members present and Supervisor Stacy voting nay, the Tazewell County Board of Supervisors hereby deny the ordinance for Circuit Court Clerk bonuses.

# Flood mitigation applications
