AN ORDINANCE FOR ADOPTION OF THE 2023 TAZEWELL COUNTY COMPREHENSIVE PLAN

WHEREAS, Section 15.2-2230 of the Code of Virginia (1950), as amended, requires that the Tazewell County Planning Commission (hereafter, "the Planning Commission") and the Tazewell County Board of Supervisors (hereafter, "the Board") review the Tazewell County Comprehensive Plan (hereafter, "the Plan") to determine whether or not it is advisable to amend the Plan:

WHEREAS, subsequent to the 2017 Tazewell County Comprehensive Plan, the Planning Commission reviewed the Plan in 2022 and determined that it was advisable to amend the Plan, given the changes necessitated by the COVID-19 pandemic and the data from the 2020 United States Census;

WHEREAS, the Planning Commission worked for eighteen (18) months diligently reviewing and considering every section of the Plan, making a significant number of revisions where appropriate and necessary;

WHEREAS, after a duly advertised public hearing on March 14, 2024 in accordance with Sections 15.2-2204(A) and 15.2-2225 of the Code of Virginia (1950), as amended, the Planning Commission unanimously resolved and recommended that the Board consider and approve the 2023 Tazewell County Comprehensive Plan as submitted:

WHEREAS, the Board FINDS that the 2023 Tazewell County Comprehensive Plan as submitted is an appropriate and advisable revision to the Plan, and in so doing commends the Planning Commission for its tireless work in revising the Plan; and

WHEREAS, pursuant to Sections 15.2-2204(A) and 15.2-2223 of the Code of Virginia (1950), as amended, the Board desires to adopt the 2023 Tazewell County Comprehensive Plan at this duly advertised public hearing, subsequent to the public hearing held by the Planning Commission on March 14, 2024;

NOW THEREFORE, be it ORDAINED that pursuant to Section 15.2-2223 of the Code of Virginia (1950), as amended, the Board does adopt the 2023 Tazewell County Comprehensive Plan as submitted by the Tazewell County Planning Commission, such Plan being incorporated herein. The Board further directs that the Planning Commission next review the plan beginning July 2028 to determine whether or not it is advisable to amend the plan, in accordance with Section 15.2-2230 of the Code of Virginia (1950), as amended
