Chairperson Robinson: Meeting at Nuckols Hall, Tuesday, January 23rd, 2024 at 6:00 P.M.

Chase Collins: "House Bill 636 --- <u>Senate Bill 567</u>, from Sen. Creigh Deeds, D-Charlottesville, and <u>House Bill 636</u>, from Del. Richard "Rip" Sullivan Jr., D-Fairfax County, would apply to solar energy facilities of at least 50 megawatts, wind energy facilities of at least 100 megawatts, and battery storage facilities of at least 50 megawatts. The idea, Deeds said in an interview, is to think of utility-scale renewable energy from a statewide perspective rather than as a strictly local issue.

"This is the development of sufficient energy so that we have reliable, affordable, safe energy, and we're reducing carbon at the same time," Deeds said. "You know, it is in the interest of every single Virginian. It's a Virginia issue. It's a statewide issue."

Applicants planning such large renewable energy projects would be able to turn to the State Corporation Commission instead of a local government for approval of a project's location if:

- a locality fails to approve or deny the application in a timely manner; or
- the applicant complies with certain state requirements but the locality denies it anyway; or
- the locality notifies an applicant that its project is locally compatible, but then amends its zoning laws in a way that adds additional, more restrictive requirements."
