

NOTICE TO BIDDERS.

The Board of Supervisors of Tazewell County, Virginia is currently accepting sealed bids from qualified contractors to perform asphalt overlay paving with Bituminous Asphalt (Plant Mix) on various orphan roads in Tazewell County. As a matter of general information, each bidder must provide proof of the following, direct specific points outlined below.

GENERAL INFORMATION

- I. A **responsible** bidder will:
 1. Provide proof that they are a licensed contractor in the Commonwealth of Virginia
 2. Provide proof of liability insurance in the amount of \$1 Million Dollars
 3. Pledge that they are in compliance or will comply with all workers compensation laws of the Commonwealth of Virginia.
 4. Provide a list of equipment available to them to deploy on the project and their anticipated hours of labor they intend to use on the project.
 5. Provide proof of bidder's corporate status where applicable.
- II. A **responsive** bid will state the price for the materials and labor for performing the improvements indicated on the attached sheet for each lot, based on the length, width, and estimated tonnage indicated.

ACKNOWLEDGEMENT BY BIDDER

Bidder acknowledges that the following will be incorporated by reference into the Contract awarded.

1. A contract will be awarded for each lot as described on the attached specifications sheets including the field narrative, schedule and maps.
2. Bidder assumes the responsibility of locating the road to be improved and incorporating any mobilization costs related thereto into the bid.
3. Bidder will proceed with the project within 10 days of the Notice to Proceed.
4. The County reserves the right to reject all bids.
5. Bidder will submit an invoice to the county upon completion of work. The county will pay for work after its completion in accordance with the Prompt Payment Act.
6. Bidder is responsible for verifying all estimates provided.
7. Tazewell County will not pay for any work that does not have written authorization from the Director of Engineering
8. Completion of work shall be finished no later than **August 31, 2024** Failure to meet this deadline will result in liquidated damages of \$100 per day per uncompleted lot.

I have read and understand the proceeding Bid Qualifications. I agree that any contract I am awarded for this project will be subject to these terms.

FIELD NARRATIVE

This project shall consist of furnishing and placement of Bituminous Asphalt (Plant Mix) overlay pavement courses on existing roadways surfaces in accordance with the requirements of the Virginia Department of Transportation 2007 Road and Bridge Specifications and in reasonably close conformity with the lines, grades, and thickness as established by the schedule of work shown in the contract or as directed by the Engineer.

Traffic control is to be in accordance with 2005 Virginia Work Area Protection Manual.

TECHNICAL INFORMATION

1. Tazewell County calls for the application of one and one-half inches (1 ½") of compacted Bituminous Asphalt (Plant Mix) Overlay, unless otherwise noted.
2. Measurements for the road shall be taken from edge of asphalt to edge of asphalt
3. Type of asphalt: SM-9.5AL for all overlays, BM-25.0 for base asphalt.
4. Adequate crown shall be provided to allow for proper drainage.
5. Tonnage tickets with the following information shall be provided to the Tazewell County Engineer or his designee for each load of material used.
 - Signature of Certified Weight Person
 - Date
 - Truck Number
 - Load Number
 - Plant Name
 - Size and Type of Material
6. The project manager shall be responsible for reconciling his copies of tonnage tickets with those provided to the Tazewell County Director of Engineering or his designee at the completion of each Road.
7. No Payment shall be made for material delivered in excess of the legal load limits established for each truck.
8. Siltation control measures shall be applied to erodible material exposed by any activity associated with construction, including clearing or grubbing, but not limited to local materials sources, stockpiles, disposal area, and haul roads and shall be functional before land-disturbing activities take place.
9. Lot Number 6(Add alternate) Price will need to include the price to mill the Road.
10. Lot Number 6(Add alternate) will require that work be done when the court house is closed.

Following is a list of each street for which bids are sought where a length and width range for roads for varying widths. It is the contracts responsible to verify the widths. All measurements are to be taken from edge of asphalt to edge of asphalt

The bids should incorporate the following:

- Mobilization
- Verified Tonnages
- Additional asphalt needed to account for the condition of the road
- Any stone that may be necessary
- Tonnage calculations need to take into account any flaring at entrances and intersections along the road

Bidder shall submit a price per ton applied for each lot. Bidder shall tabulate and submit a total price for each lot.

Tazewell reserves the right to remove roads from lots

All questions must be submitted in writing, preferably email, By 6/20/24. All answers will be provided to the attendees of the pre-bid meeting.
