PROTECTIVE GEAR AND EQUIPMENT CARRIERS

The **Tazewell County Sheriff's Office** ("TCSO") is soliciting bids from qualified vendors, pursuant to Section 2.2-4300 *et seq.* of the Code of Virginia (1950), as amended, to provide the following goods and services:

ITEM	PRICE PER UNIT
(1) Level III(A) Point Blank Panels with Soft Trauma Plate*	
(2) Black or White Concealable Carrier	
(3) Midnight Blue Outer Carrier Guardian – Generation 3	

* **No substitutions allowed**

TCSO intends to enter into a contract with the successful vendor for delivery of the above-mentioned goods on a basis of **price per unit**, subject to the following terms and conditions:

- (1) The successful vendor must travel to TCSO for all vest and equipment meetings within a reasonable time of delivery of goods, which shall not exceed thirty (30) days.
- (2) The term of the contract between TCSO and the successful vendor will be two (2) years, comprised of a one (1)-year initial term and a one (1)-year renewal term.
- (3) This procurement is also being conducted on behalf of other law enforcement agencies, including Sheriff's Offices and Police Departments, which are public entities of the Commonwealth of Virginia. Any such public entity that desires to contract with the successful vendor shall do so by a separate, identical agreement with the successful vendor, being procured through cooperative procurement pursuant to Section 2.2-4304(A) of the Code of Virginia (1950), as amended.
